REGULAR MEETING June 1, 2020

A regular meeting of the North Brunswick Township Council was held on Monday, June 1, 2020 (Via Go To Meeting) at 7:00 p.m. in the Municipal Complex located at 710 Hermann Road, North Brunswick, Middlesex County, New Jersey.

### Reports from Mayor, Council, Administrator, CFO

Councilwoman Guadagnino speaks regarding the water meter project resuming today. In Line Services will reach out to residents to sign up. In Line Services will out line all procedures for when they come out to replace. The company will have photo IDs, a badge from the company. The new website has many new features. Ms. Guadagnino encourages everyone to sign up.

Director Hritz speaks about Governor Murphy allowing outdoor dining starting June 15. All information is on Township website.

Council President Andrews makes mention of peoples comments on meeting regarding Police Department and Public Parks.

Mayor Womack comments on protocol for residents wearing masks. Mayor Womack also comments on residents at Public Parks.

Council President Andrews speaks regarding Township cable and internet. Optimum has noticed numerous complaints on internet going down, the Township is monitoring it. On the Township website there is a place for referrals to customer service. Council President Andrews states it is being worked on and it will continue until it is fixed.

Mayor Womack asks Township attorney Ron Gordon how the comments being posted on "Go To Meeting" should be addressed. Mr. Gordon states they should be addressed in the Public Hearing portion of the meeting.

Mayor Womack reads comment on "Go To Meeting" - at 7:06 PM message from VM states... "I still find New Brunswick Police, extremely rude and unprofessional especially in areas that are mostly populated in non-white neighborhoods. Police continuously harass people who are waiting at a bus stop or at a train station." (message attached) Mayor Womack responds to comment that the police department will follow up.

Mayor Womack reads comment on "Go To Meeting" – at 7:07 PM message from Richard Rivera states... "accreditation is meaningless if a police agency does not live up to expectations. Lets keep working on accountability – Rich" (message attached) Mayor Womack responds message will be forwarded to police for review.

Mayor Womack reads comment on "Go To Meeting" – at 7:09 PM message from VM states... "I have seen police hand out tickets for "suspicious driving" even when that means coming from Stop and Shop and driving home. Police has stopped and tickets to citizen who have dash cams, but people who have phone mounts on the windows get away." (message attached) Mayor Womack responds he will forward to police for assessment.

Mayor Womack reads comment on "Go To Meeting" – at 7:22 PM message from VM states... "What are you doing regarding enforcing social distancing with COVID-19?" (message attached) Mayor Womack responds to comment.

Mayor Womack reads comment on "Go To Meeting" – at 7:28 PM message from VM states... "Internet is a service that we pay for, can you please introduce legislation to make sure Optimum and Altice reimburse us back for any service outages" PSEG does it for their electricity when households don't have power—even if we loose power for an hour." (message attached) Mayor Womack asks Township attorney Ron Gordon to address, Mr. Gordon, Council President Andrews and Mayor Womack all give answers.

Mayor Womack called for a motion to close the Public Hearing at 7:37PM, so moved by Mr. Davis second by Mr. Socio.
