WHEREAS, by adding names of local Wartime Veterans to public street signs, we hope to promote public awareness of these individuals and show our appreciation for their outstanding contributions and service to our country as a member of the United States Armed Forces; and

WHEREAS, eligible military candidates for this honor include honorably discharged Veterans having served in Military Departments as defined under Department of Defense which include Departments of the Army, Navy and Air Forces, as well as the Marine Corps and the Coast Guard; and

WHEREAS Wartime Veterans are individuals who served in the active military forces, during a period of armed conflict or who received the armed forces expeditionary or other campaign service medals during an emergency condition, including those who died in the line of duty in the active military forces; and

WHEREAS, Anthony J. Guerriero. has been selected to be recognized in the Veteran Street Sign Program; and

WHEREAS, Anthony was born September 24, 1930 to Antonette and Anthony Guerriero; and

WHEREAS, Anthony joined the Navy in November of 1950 after graduating from St. Peters High School in New Brunswick. He did his basic training in Norfolk, Virginia and was placed on the Kula Gulf and other ships serving as a Seaman Aviation E-3 from 1950-1952 during the Korean War; and

WHEREAS, Anthony was stationed in Guantanamo Bay and traveled to Jamaica, San Salvador and England; and

WHEREAS, Anthony was honorably discharged in 1952 and moved to North Brunswick. He has been a Township resident for sixty-four years; and

WHEREAS, Anthony was married to "Sugar" Anna Parillo for fifty years and together they raised three children, Judy, Anthony and Lisa. He has seven grandchildren and seven great grandchildren; and

WHEREAS, Anthony was employed by the Township of North Brunswick and retired after twenty-seven years of service as a foreman in the Department of Public Works; and

WHEREAS, Anthony is a member of the Adams AC where he volunteers at events, enjoys playing cards, going on trips to the casinos with his buddies and attending just about all events for his children and grandchildren even when he has to travel to Ohio:
