Explain the project including the objectives and how it will effectively improve the municipality's recycling program.

Illegal dumping is a chronic issue costing cities and counties millions of dollars annually. Specifically, the illegal dumping at the dam in Lake Farrington in North Brunswick is of concern. Besides the blight and costly clean up, these issues can create health and environmental issues, impact property values and it may be only a matter of time before an incident occurs that will cost North Brunswick significant time and materials to mitigate. Issues such as these, raise concerns about overall public safety, declining property values and the well-being of the community.

My proposal is for a camera to be installed at the source to address the crime. The camera system (FlashCAM) has unique features to stop criminals, including high resolution images (motion-triggered strobe flash) & voice warning, so it is able to capture license plates, illegal activity and suspect images even in complete darkness. No infrastructure is required, as the camera system is completely self-contained with a solar charged battery operation & battery life of 5 years, this simplifies installations. The camera system is portable, allowing the township to move it to other locations as may be needed.
