

**A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK
AUTHORIZING AN AMENDMENT TO CONTRACT BID19007
WITH J. FLETCHER CREAMER & SON INC.
FOR SEWER AND STORMWATER COLLECTION SYSTEM
MAINTENANCE AND REPAIR SERVICES**

WHEREAS, the Department of Public Works Sewer Division is responsible for providing maintenance and repairs to the municipal sanitary system; and

WHEREAS, in May of 2019, pursuant to Resolution 138-5.19, a contract was authorized with J. Fletcher Creamer & Son Inc. (101 East Broadway, Hackensack, NJ 07601) in the amount of \$150,000.00 to provide sewer and stormwater collection systems maintenance and repair services based on estimated quantities on the proposal schedule, listing hourly rates for services on an as-needed basis, with a two-year term beginning May 1, 2019 and ending April 30, 2021, and included the option for one additional two-year extension; and

WHEREAS, the Director of the Department of Public Works, determined there is a continued need to have a third party company available to provide sewer and stormwater collection systems maintenance and repair services and recommends authorizing an additional two-year extension, with no increase in the current authorization amount of \$150,000.00; and

WHEREAS, the Chief Financial Officer has certified that \$10,000.00 is available for this purpose in FY2021 Sewer Operating – Maintenance and Repair Account 1-07-55-502-000-183 for services ending June 30, 2021 and the balance shall be certified upon the appropriation of funding in future fiscal years.

NOW, THEREFORE, BE IT RESOLVED, on this 17th day of May 2021, that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an amendment to the agreement with J. Fletcher Creamer & Son Inc. extending the contract term by two years, from May 1, 2021 – April 30, 2023, for sewer and stormwater collection systems maintenance and repair services, with no increase in the current authorization amount of \$150,000.00, pursuant to contract BID19007.
