

**A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK  
AUTHORIZING AN AMENDMENT OF CONTRACT BID19012  
TO NATIONAL WATER MAIN CLEANING CO.  
FOR SEWER JET VAC SERVICES**

**WHEREAS**, the Department of Public Works Sewer Division provides for maintenance and repairs to the municipal wastewater distribution system which includes various pipe lines, manholes and pump stations; and

**WHEREAS**, in February of 2020, pursuant to Resolution 71-2.20, the Township authorized an agreement with National Water Main Cleaning Co. (1806 Newark Turnpike Kearney, NJ 07032) for Sewer Jet Vac Services pursuant to contract BID19012, in an amount not-to-exceed \$50,000.00, with a two-year term (February 1, 2020 – January 31, 2022), reserving the option for two (2) additional one-year terms; and

**WHEREAS**, due to the unanticipated continuation of the need to maintain and repair the manholes within the township, it has become necessary to increase the authorized amount from \$50,000.00 to \$70,000.00, a net increase of \$20,000.00.

**WHEREAS**, funds in the amount of \$10,000.00 are available for this purpose within the FY2021 Sewer Operating – Maintenance and Repair budget under account 1-07-55-502-000-183 for services ending June 30, 2021, and the balance shall be certified upon the appropriation of funding in future fiscal years; and

**NOW THEREFORE, BE IT RESOLVED**, on this 1<sup>st</sup> day of June 2021, that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an amendment with National Water Main Cleaning Co. to provide Sewer Jet Vac Services, pursuant to contract BID19012, to increase the authorization amount from \$50,000.00 to \$70,000.00.
