A RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF NORTH BRUNSWICK AUTHORIZING THE EXECUTION OF AN INDEMNITY AND HOLD HARMLESS AGREEMENT WITH ADTALEM GLOBAL EDUCATION, INC. FOR THE 2021 YOUTH SPORTS FESTIVAL

WHEREAS, the North Brunswick Youth Sports Festival is a nonprofit organization of which assists in providing funding for Youth Soccer Games of North Brunswick – Adams AC Football and Cheerleading, North Brunswick Soccer Club, North Brunswick Baseball and Softball Association and the North Brunswick Travel Basketball Association; and

WHEREAS, the North Brunswick Youth Sports Festival also provides direct municipal support in the form of municipal field maintenance and purchasing related sporting equipment; and

WHEREAS, the North Brunswick Youth Sports Festival has received the approval of the Township Council of the Township of North Brunswick to hold a large event known as the "2021 Youth Sports Festival" at state property, as well as on the grounds of the former DeVry Institute of Technology at 630 US Highway One, North Brunswick, NJ (the "Premise"), which is currently owned by Adtalem Global Education, Inc. ("ATGE"); and

WHEREAS, ATGE has agreed to permit the North Brunswick Youth Sports Festival to use certain specific locations of the Premise for the purpose of the parking of event staff and overflow event visitors during the 2021 Youth Sports Festival, and ATGE and the North Brunswick Youth Sports Festival have agreed to the terms of a Use Agreement; and

WHEREAS, ATGE, the North Brunswick Youth Sports Festival, and the Township of North Brunswick have agreed to the terms of an Indemnity and Hold Harmless Agreement in the amount of \$5,000.00, in a form substantially the same as that attached hereto; and

NOW THEREFORE, BE IT RESOLVED, by the Township Council of the Township of North Brunswick that the Mayor or the Business Administrator, with the Township Clerk ad witness, are hereby authorized to execute the Indemnity and Hold Harmless Agreement in an amount of \$5,000.00 for the 2021 Youth Sports Festival, in a form substantially the same as that attached hereto, subject to the following conditions:

- 1. This agreement is the entire agreement between the Parties and no alterations, changes or additions herein shall be made except in writing and approved by through a written amendment approved by the respective local government bodies.
- 2. The duration of this agreement shall remain in effect for the duration of the North Brunswick Youth Sports Festival.

IN WITNESS THEREOF, the North Brunswick Youth Sports Festival and Municipality shall cause this agreement to be executed by their proper contracting agents and their proper corporate seals affixed this day and year above written.

BE IT FURTHER RESOLVED, Township Council of the Township of North Brunswick does hereby authorize the Mayor and Township Clerk to execute this agreement with ATGE and the North Brunswick Youth Sports Festival.

BE IT FURTHER RESOLVED, that a copy of this Resolution shall be certified and forwarded to the Division of Local Government Services.

TITLE

This Resolution shall be known and may be cited as a Resolution Authorizing the Execution of an Indemnity and Hold Harmless Agreement with Adtalem Global Education, Inc. for the 2021 Youth Sports Festival.
