

**A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK  
AUTHORIZING AN AMENDMENT TO CONTRACT BID19012  
WITH NATIONAL WATER MAIN CLEANING CO.  
FOR SEWER JET VAC SERVICES**

**WHEREAS**, the Department of Public Works Sewer Division provides for maintenance and repairs to the municipal wastewater distribution system which includes various pipe lines, manholes and pump stations; and

**WHEREAS**, on February 3, 2020, pursuant to Resolution 71-2.20, a contract was authorized with National Water Main Cleaning Co. (1806 Newark Turnpike Kearney, NJ 07032) in the amount not-to-exceed \$50,000.00 to provide sewer jet vac services based on estimated quantities on the proposal schedule, in the amount of \$3,136.90 for goods and services identified as items 1-15, with a two-year term beginning February 1, 2020 and ending January 31, 2022, and included the option for two additional one-year renewals; and

**WHEREAS**, due to the increase in sewer jet vac services, it has become necessary to increase the authorized amount from \$50,000.00 to \$75,000.00, a net increase of \$25,000.00; and

**WHEREAS**, the Chief Financial Officer has certified that \$10,000.00 is available for this purpose in FY2021 Sewer Operating – Maintenance and Repair Account 1-07-55-502-000-183 for services ending June 30, 2021 and the balance shall be certified upon the appropriation of funding in future fiscal years.

**NOW, THEREFORE, BE IT RESOLVED**, on this 29<sup>th</sup> day of June 2021, that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an amendment to the agreement with National Water Main Cleaning Co. increasing the current authorization amount from \$50,000.00 to \$75,000.00, a net increase of \$25,000.00, pursuant to contract BID19012.
