I am writing this letter to testify that


- 1.- I never received the letter that you say your office sent me



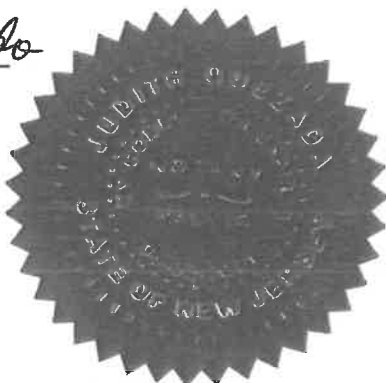


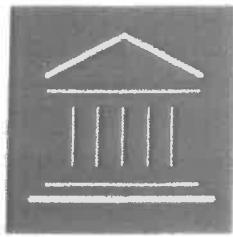

Please be further advised that failure to renew your Taxi Owner's License in connection with the above Taxi Medallion numbers and pay the minimum fee of \$250.00 per Taxi Medallion by March 1, 2021 will result in a forfeiture and reversion of your Taxi Owner's License and Taxi Medallions to the Township.
