

**RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK COUNCIL  
AUTHORIZING PRIMOS TAXI INC TO APPLY FOR RENEWAL OF TAXI OWNER  
LICENSES FOR MEDALLIONS #4, #10, #11 AND #24**

**WHEREAS**, Primos Taxi Inc. was the owner of Taxi Owner Licenses for Medallions #4, #10, #11 and #24; and

**WHEREAS**, North Brunswick Code Section 311-10 specifies that all Taxi Owner's Licenses shall expire on December 31<sup>st</sup> of the year in which it was issued; and

**WHEREAS**, Primos Taxi Inc. failed to apply for renewal of Taxi Owner Licenses for Medallions #4, #10, #11 and #24 on or before December 31, 2020; and

**WHEREAS**, despite notices from the Township Clerk's Office, both verbally and in writing, and formal notice from the Township Attorney's Office that the process for Renewal of the Medallions needed to be completed on or before March 1, 2021 or risk forfeiture of the licenses; and

**WHEREAS**, the procedure for renewal of the Taxi Owner License Medallions was not completed by March 1, 2021; and

**WHEREAS**, pursuant to the procedure authorized by Section 311-19 of the Code of the Township of North Brunswick which permits a Taxi Owner's License Holder to be given an opportunity for a hearing before the Township Council requesting the ability to apply for reinstatement of Taxi Owner Licenses Medallions #4, #10, #11 and #24; and

**WHEREAS**, a hearing was held before the Township Council of the Township of North Brunswick on June 29, 2021, as requested by Primos Taxi Inc., to determine whether to allow for the application to reinstate the Taxi Owner Licenses Medallions; and

**WHEREAS**, the Township Council of the Township of North Brunswick has determined to permit Primos Taxi Inc. to apply for reinstatement and reissuance of Taxi Owner's Licenses Medallions #4, #10, #11 and #24 provided that all of the requirements of the Code of the Township of North Brunswick regarding Taxi Owner Licenses as contained in Chapter 311 of the Code of the Township of North Brunswick entitled "Taxi Cabs" have been satisfied.

**NOW, THEREFORE, BE IT RESOLVED** on this \_\_\_ day of \_\_\_\_\_, 2021, by the Township Council of the Township of North Brunswick that Primos Taxi Inc. shall be permitted to apply for the reinstatement of and reissuance of Tax Owner's Licenses Medallions #4, #10, #11 and #24 provided that all procedural requirements as contained in Chapter 311 of the Code of the Township of North Brunswick entitled "Taxi Cabs" are complied with within thirty (30) of the date of this ratifying Resolution.
