

**A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK
AUTHORIZING A CONTRACT WITH
KOCH 33 FORD
FOR TWO REPLACEMENT UNMARKED VEHICLES**

WHEREAS, there is a need to replace two (2) unmarked vehicles within the Department of Public Safety's fleet that have exceeded their useful life; and

WHEREAS, it is hereby the Police Chief's recommendation to the Mayor and Council to solicit proposals for two replacement vehicles within the Detective Bureau; and

WHEREAS, funding for the purchase of the two vehicles was included in the Temporary FY22 Police Operating Budget; and

WHEREAS, on August 2, 2021 the Township Council approved Resolution 237-8.21 which acknowledged the solicitation of quotations for the purchase and delivery of two (2) unmarked police vehicles; and

WHEREAS, the Purchasing Agent received one (1) quote on August 24, 2021; and

WHEREAS, the quote submitted by Koch 33 Ford (3810 Hecktown Road Easton, PA 18045) in the amount of \$28,818.00 for the purchase and delivery one (1) unmarked 2021 Ford Explorer, a total cost of \$57,636.00, was determined to be the lowest responsible respondent; and

NOW THEREFORE, BE IT RESOLVED, that the formal quote submitted by Koch 33 Ford is hereby accepted.

BE IT FURTHER RESOLVED, on this 13th day of September 2021, that the Township Council of the Township of North Brunswick does hereby acknowledge and authorize the execution of contract PRO21049, awarded to Koch 33 Ford, for the purchase and delivery of two (2) 2021 Ford Explorers in the amount of \$57,636.00.


