Instructions to the Voter

- 1. Use only black pen to mark your ballot.
- 2. To vote for any candidate whose name is printed on this ballot, fill in the oval to the right of the candidate's name (from this ○, to this ●). Do not vote for more than the number of candidates to be elected to each office.

 3. To vote for a person whose name is not printed on this ballot, write the person's name on the blank line(s) (marked "Write-In") across from the proper title of office and fill in the oval to the right of the name (from this ○, to this ●).
- 4. To vote on a Public Question, fill in the oval to the right of the word "Yes" or "No" (from this ∅, to this ♠).

 5. Do not mark this ballot in any manner other than provided for. If you spoil your ballot, request a new one from the County Clerk's office. If you mark your ballot in such a way that your intent is unclear, or if you vote for more than the number to be elected to an office, your vote for that office will not be counted.

 TO PROTECT YOUR VOTE: IT IS AGAINST THE LAW FOR ANYONE EXCEPT YOU, THE VOTER, TO MARK OR INSPECT THIS BALLOT. However, a family member may assist you in doing so.
