SPECIAL MEETING August 23, 2021

A Special Meeting of the North Brunswick Township Council was held on Monday August 23, 2021 at 7:00 pm in the Municipal Complex located at 710 Hermann Road, North Brunswick, Middlesex County, New Jersey **Hybrid – Live and Via GoToMeeting**

Council President Socio called the meeting to order.

Roll call:

Ms. Russo announced that the notice requirements of the law have been satisfied. Notices were sent by certified mail on December 30, 2020 to the following:

Mayor Womack arrives at 7:01pm.

Council President Socio explains this is a special meeting to discuss Ordinance #21-14 – An ordinance to amend the Code of The Township of North Brunswick, County of Middlesex, State of New Jersey, by adding Chapter 28, authorizing the Establishment of a Community Aggregation Program that creates an option for 100% regionally sourced renewables

Township attorney Ron Gordon explains how the municipality operates under the Faulkner Act. Mr. Gordon explains about Initiative and referendum petitions and the process of proceeding with them. The Township has gone through the procedural Part, now it moves onto 2nd reading and Public Hearing portion. Mr. Gordon explains how to move forward and what happens if the ordinance is or is not adopted by the council. If it is not adopted by the council then it moves to a referendum through the next General Election or through a Special Election. The Township is still waiting to hear back from The Board of Elections and the County Clerk for clarification on which election it would be on.

Mayor Womack asks a question on how the timing works, Mr. Gordon answers.

Council President Socio asks why this is an opt-out not opt-in program? Councilman Andrews and Mr. Gordon answers

Councilman Andrews asks if the Township would have to pick what company the Township would go through? Mr. Gordon answers.

Councilman Davis asks if all municipalities will be involved in this program? Mr. Gordon answers. Councilman Davis asks if this goes into effect can it fail after a certain amount of time? Mr. Gordon answers Councilman Davis asks if this will be a savings for the residence if it goes into effect? Mr. Gordon answers Discussion continues with Mr. Gordon, Councilman Davis and Councilman Andrews.

Ms. Guadagnino asks if the wording in the ordinance can be changed? Mr. Gordon answers

Councilman Andrews asks what the options are for the Council to vote on this? Mr. Gordon answers

Mayor Womack opened the Public Hearing at 7:26pm

Evie Gresh (virtually – on screen as North Brunswick Resident) – asks How can people opt out? Attorney Vaugh Parchment answers. Council President Socio asks what happens if residents wait to long and is after the allotted time frame? Mr. Parchment answers. Ms. Gresh asks how will residents know? Mr. Gordon and Mr. Parchment answers. Ms. Gresh asks what makes this go to a vote? Mayor Womack answers.

Debbie Ramlet (virtually) – asks What cost savings are occurring in other towns that have adopted this? Mr. Gordon answers Mayor Womack states Mayor Waller from Piscataway says he does not believe he has seen any savings yet. Ms. Ramlet asks does it cost anything to residents to have this? Mr. Gordon answers

Mayor Womack called for a motion to close Public Hearing so moved by Council President Socio second by Mr. Davis
