

**A RESOLUTION AUTHORIZING RECLASIFICATION OF
COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDS –
\$118,029.00 FOR PROGRAM YEAR 2020**

WHEREAS, the Township Council of the Township of North Brunswick received notice, from the office of Middlesex County Housing and Community Development, of a Community Development Block Grant (CDBG) for program year 2020 in the amount of \$118,029.00; and

WHEREAS, the Middlesex County Housing and Community Development office has recommended that the allocation for the program year 2020 Consolidation Plan be proposed in the amount of \$118,029.00 and be utilized for the Individual Housing Rehabilitation Program, Code Enforcement Property Maintenance Program, and the Senior Center Handicap Building Improvements, for the fiscal year July 1, 2020 – June 30, 2021; and

WHEREAS, the Middlesex County Housing and Community Development office has provided subsequent notice of additional funding in the amount of \$685.00, creating a new revised total allocation of \$118,714.00; and

WHEREAS, the North Brunswick Citizens Advisory Committee is responsive to a staff request from the North Brunswick Senior Citizen Center that the side entrance doors need replacement, with a total cost estimate of \$5,610.00, and recommend funding this improvement; and

WHEREAS, the CDBG Program Administrator has determined that funding for this purpose in the amount of \$3,846.00 can be reclassified from the Individual Housing Rehabilitation Deferred Loan Program;

NOW THEREFORE BE IT RESOLVED, on the 18th day of October, 2021, by the Township Council of the Township of North Brunswick, that the use of CDBG funds are hereby reclassified in accordance with additional funding provided by the Middlesex County Housing and Community Development office and the recommendation of the North Brunswick Citizens Advisory Committee as follows:
