

**A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK  
AUTHORIZING THE AWARD OF CONTRACT BID21006  
TO \_\_\_\_\_  
FOR SNOW REMOVAL SERVICES**

**WHEREAS**, the Department of Public Works Street and Roads Division is responsible for providing snow removal services from public streets and access ways; and

**WHEREAS**, in addition to the Street and Roads Division provided snow removal, the Department currently contracts out for supplemental services during large snow events; and

**WHEREAS**, Eric Chaszar, Director of the Department of Public Works, determined there is a need to have supplemental resources available due to the unpredictability of snow events; and

**WHEREAS**, on September 13, 2021 the Township Council approved Resolution #254-9.21 authorizing advertisement for receipt of bids for Snow Removal Services, BID21006; and

**WHEREAS**, a bid opening was held on October 15, 2021 and no bids were received; and

**WHEREAS**, on October 18, 2021 the Township Council approved Resolution #294-10-21 authorizing the re-advertisement for receipt of bids for Snow Removal Services, BID21006; and

**WHEREAS**, a bid opening was held on November 4, 2021 and no bids were received; and

**WHEREAS**, pursuant to N.J.S.A. 40A11:5(3) when a bid has been formally advertised on two occasions and no qualified vendor has responded, a contract may be negotiated; and

**WHEREAS**, in November 2021, the Director of Public Works met with \_\_\_\_\_; and

**WHEREAS**, in November 2021, the Director of Public Works recommends approval of a contract with \_\_\_\_\_ which includes negotiated terms and conditions; and

**WHEREAS**, within the bid specifications for BID21006 for Snow Removal Services, the Township will award the contract to a primary vendor and a secondary vendor in the event the primary vendor cannot provide the manpower/equipment proposed; and

**WHEREAS**, the two-year contract with \_\_\_\_\_ as the *secondary vendor* shall commence on November 15, 2021 and end November 14, 2023 and includes an option for two additional one-year extensions.

**NOW THEREFORE, BE IT RESOLVED**, that the negotiated contract with \_\_\_\_\_ is hereby accepted.

**BE IT FURTHER RESOLVED**, on this 15<sup>th</sup> day of November 2021 that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness contract BID21006 with \_\_\_\_\_ to provide Snow Removal Services as the *secondary vendor* in the amount of not-to-exceed \$ \_\_\_\_\_ with a two-year term (November 15, 2021 – November 14, 2023) with two (2) optional one-year extensions.
