

**RESOLUTION AUTHORIZING THE ACCEPTANCE OF A  
MIDDLESEX COUNTY  
DEPARTMENT ON AGING GRANT  
SENIOR OUTREACH ADDITIONAL FUNDING- \$10,000.00**

**WHEREAS**, the County of Middlesex entered into a contract with the State of New Jersey, Department of Health and Senior Services, for the purpose of providing services primarily for older adults under the County Department on Aging Area Plan; and

**WHEREAS**, under the Rules and Regulations for County Offices on Aging, N.J.A.C. 5:71-1.2 and, the County Department on Aging Area Plan Contract, the County Department on Aging has been provided the authority and responsibility to administer these Programs; and

**WHEREAS**, the Aging Area Plan Contract with the New Jersey Department of Health and Senior Services stipulates the County of Middlesex, Department on Aging will provide additional funding for outreach services through an agreement with the North Brunswick Township Senior Center; and

**WHEREAS**, the contract between the Township of North Brunswick and County of Middlesex Department on Aging calls for a minimum of 80 unduplicated senior clients to be provided service to with a commitment from the County for one year; and

**WHEREAS**, the Director of the Department of Parks, Recreation and Community Services requests acceptance of additional funding from the Middlesex County Department on Aging in the amount of \$10,000.00 to assist North Brunswick in senior citizen outreach programs; and

**WHEREAS**, the Chief Financial Officer reviewed the grant approval and the corresponding conditions of award and recommends Council to approve said request; and

**NOW, THEREFORE, BE IT RESOLVED**, the Township Council of the Township North Brunswick does hereby authorize the acceptance of additional funding from the Middlesex County Department on Aging Grant Program in the amount of \$10,000.00 to assist in senior citizen outreach programs.

Amend Resolution #21-67-R Dated January 21, 2021 Which Authorized The County Of Middlesex To Extend The Contract With North Brunswick Senior Center For Outreach Services As Required By The Middlesex County Office Of Aging And Disabled Services For An Additional Year From January 1, 2021 Through December 31, 2021 In The Total Amount Of \$10,500.00 To Increase Funding By \$10,000.00 For A New Total Contract Amount Of \$20,500.00 (Grant Funded)

WHEREAS, by resolution dated December 6, 2018 (#18-1719-R), the County entered into a Grant Contract with the North Brunswick Senior Center for outreach services in the total amount of \$10,500.00 for the period of January 1, 2019 to December 31, 2019, as required by the Middlesex County Office of Aging and Disabled Services, with the option to extend the contract for a second and third year; and

WHEREAS, by resolution dated January 16, 2020 (#20-63-R) the contract was extended for a second year, and by resolution dated January 21, 2021 (#21-67-R) the County exercised the option to extend the contract for an additional year for the period of January 1, 2021 through December 31, 2021 in the total amount of \$10,500.00; and

WHEREAS, the Director of the Office of Aging & Disabled Services, advises that it is necessary to amend the aforesaid resolution to increase funding by \$10,000.00 for a new total contract amount of \$20,500.00;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of the County of Middlesex that resolution dated January 21, 2021 (#21-67-R), which authorized the County of Middlesex to exercise the option to extend the contract with the North Brunswick Senior Center for outreach services shall be and is hereby amended to increase funding by \$10,000.00 for a new total contract amount of \$20,500.00;
