

**A RESOLUTION AUTHORIZING THE PURCHASE OF GOODS AND SERVICES FROM VENDORS APPROVED UNDER COOPERATIVE PURCHASING AGREEMENTS**

**WHEREAS**, N.J.S.A. 40A:11-11(5) authorizes contracting units to establish a Cooperative Pricing System and to enter into Cooperative Pricing Agreements with other contracting units as defined under N.J.S.A. 40A:11-2(1) for its procurement of goods and services; and

**WHEREAS**, the Township of North Brunswick, as a local government contracting unit, has previously entered into Cooperative Pricing Agreements with the following contracting units:

**WHEREAS**, the Township may without advertising for bids, purchase any materials, supplies, services or equipment under an approved cooperative contract, for the purchase of such items, whereby the contracting unit serving as the lead agent has complied with the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey; and

**WHEREAS**, the Township Council hereby authorizes an open-ended agreement with the attached list (Schedule A) of vendors approved under Cooperative Pricing Agreements through this resolution, and properly executed purchase orders, which agreements shall be subject to all conditions applicable under the Cooperative Pricing Agreement for said goods and services; and

**WHEREAS**, the Township Council desires to authorize the purchase of certain items from approved Cooperative Pricing Agreement vendors.

**NOW THEREFORE BE IT RESOLVED**, Township Council of the Township of North Brunswick does hereby authorize of North Brunswick Township, Middlesex County, New Jersey hereby authorize the following:

1. That this Resolution shall constitute an agreement between the Township of North Brunswick and Cooperative Pricing Agreement vendors, as set forth on the attached Schedule A, subject to all terms and conditions applicable to their respective current Cooperative Pricing Agreement.
2. That the Council hereby authorizes the Purchasing Agent to purchase the items set forth on Schedule A from approved Cooperative Pricing Agreement vendors, pursuant to the respective current contracts listed in said schedule.
3. That pursuant to the rules of the Local Finance Board of the State of New Jersey, that no amount of said contracts shall be chargeable or certified until such time as goods are acknowledged with a certified Purchase Order.
4. That this agreement shall expire December 31, 2022 or upon expiration of the respective vendors Contract, whichever occurs earlier.
