# A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK CONFIRMING AN EMERGENCY AND AUTHORIZING AN AGREEMENT WITH K&A EXCAVATING, CO, INC. FOR SNOW REMOVAL SERVICES UNDER THE DEPARTMENT OF PUBLIC WORKS

WHEREAS, the Department of Public Works Street and Roads Division is responsible for providing snow removal services from public streets and access ways; and

**WHEREAS,** on September 13, 2021 the Township Council approved Resolution #254-9.21 authorizing advertisement for receipt of bids for Snow Removal Services, BID21006; and

WHEREAS, a bid opening was held on October 15, 2021 and no bids were received; and

**WHEREAS,** on October 18, 2021 the Township Council approved Resolution #294-10-21 authorizing the re-advertisement for receipt of bids for Snow Removal Services, BID21006; and

WHEREAS, a bid opening was held on November 4, 2021 and no bids were received; and

WHEREAS, the Township of North Brunswick has a need to acquire snow removal services as a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.5; and

**WHEREAS**, K&A Excavating Co, Inc. (2204 Route 130 Dayton, NJ 08810) has submitted a proposal for snow removal services in the amount of \$475.00 per hour for a tandem dump truck with plow and driver and \$650.00 per hour for a 966 loader with operator; and

WHEREAS, prior to entering onto a contract with the Township, K&A Excavating Co, Inc. will have completed and submitted a Business Entity Disclosure Certification, attached hereto, which certifies that they have not made any reportable contributions to a political or candidate committee in the Township of North Brunswick in the previous one year, and that the contract will prohibit K&A Excavating Co, Inc. from making any reportable contributions through the term of the contract; and

**WHEREAS**, in addition, K&A Excavating Co, Inc. has completed and submitted a C.271 Political Contribution Disclosure Form, attached hereto, pursuant to N.J.S.A. 19:44A-20.26 et seq.; and

**NOW THEREFORE BE IT RESOLVED,** that the Township Council of the Township of North Brunswick does hereby confirm the emergency and the award of a contract made with K&A Excavating Co, Inc. in an amount not-to-exceed \$75,000.00 for snow removal services for the 2022 season.
