

**A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK
AUTHORIZING A CONTRACT WITH
BEYER BROS CORP
FOR THE PURCHASE OF ONE PICK UP TRUCK
UNDER THE DEPARTMENT OF PUBLIC WORKS**

WHEREAS, there is a need to replace a vehicle within the Department of Public Works that has exceeded its useful life (Vehicle #811, 2007 Ford F-250 pickup truck); and

WHEREAS, the Township of North Brunswick is currently a member of the Educational Services Commission of New Jersey State approved Co-op #65MCESCCPS; and

WHEREAS, Beyer Bros. Corp. (with offices at 109 Broad Avenue Fairview, NJ 07022) is an approved vendor under Educational Services Commission of New Jersey Co-Op Bid #20/21-09 for Cars, Crossovers, Pickup Trucks, SUV's and Vans; and

WHEREAS, Beyer Bros. Corp. under Bid #20/21-09 has provided a proposal for (1) 2023 GMC TK30953 - 3500 Double Cab Pick Up Truck at a cost of \$41,104.86; and

NOW THEREFORE BE IT RESOLVED, that the Township Council of the Township of North Brunswick does hereby authorize the award of a contract to Beyer Bros. Corp. in the amount of \$41,104.86 for the purchase of (1) 2023 GMC TK30953 - 3500 Double Cab Pick Up Truck.

BE IT FURTHER RESOLVED, that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an agreement with Beyer Bros. Corp. in accordance with the previously approved Educational Services Commission of New Jersey Co-Op Bid #20/21-09.
