# NORTH BRUNSWICK TOWNSHIP MINUTES....

REGULAR MEETING February 22, 2022

A regular meeting of the North Brunswick Township Council was held on Tuesday, February 22, 2022 (Via Go to Meeting) at 7:00 pm in the Municipal Complex located at 710 Hermann Road, North Brunswick, Middlesex County, New Jersey.

Council President Davis called the meeting to order.

Roll call:

Ms. Russo announced that the notice requirements of the law have been satisfied. Notices were sent by certified mail on January 4, 2022 to the following:

Notice receipts are on file in the Municipal Clerk's Office. Also, notices were posted on the bulletin board in the Municipal Complex and filed in the Municipal Clerk's Office.

Council President Davis lead the assembly in the Pledge of Allegiance.

Council President Davis asked council members if any items are to be removed from the Consent Agenda.

Ms. Guadagnino asked that item 4f be pulled from the consent agenda for further discussion.

Council President Davis called for a motion to approve items 4a to 4e and 4g to 4h on the consent agenda. Motion made by Ms. Guadagnino to approve items 4a to 4e and 4g to 4h on the agenda, second by Mr. Socio.

Ms. Guadagnino had questions about the water/sewer credits. The credits should come sooner not 4 or 5 months later. With the new system residents know that their consumption is high.

Mr. Socio asked when did the resident reach out to the Township.

Ms. Progebin replied that the Landlord notified the township 4 to 5 months after. Aug, Sept., and partial for Oct. the leak was resolved in October.

Council President Davis wanted to know who contacted the Township was it the Landlord or Tenant?

Ms. Progebin explained the Landlord was engaged with the township. The toilet was leaking for 4 months. He was only eligible for 3 months credit.

Council President Davis wanted to know why it took 3 to 4 months to correct the leak and when did the Landlord bring in the plumber.

Ms. Progebin said the Landlord or Tenant have up to 3 months to identify the leak and repair it. It took them longer.

Ms. Guadagnino – Did the Landlord/Tenant pay their bill? Was there an acknowledgement that the tenant left the home?

Mr. Socio – Is the Homeowner getting the bill or is the tenant getting the bill?

Mayor Womack – The Landlord is responsible for the bill.

Council President Davis - Did the Landlord receive any alerts of high-water usage?

Mr. Andrews – Who receives the notice the Landlord or the Tenant of high-water usage.

Mr. Andrews- if the Landlord takes a few months to correct leak who can hold the tenant responsible?

Ms. Progebin – The Township does not get involved with the Landlord/Tenant. The bill does belong to the Landlord.

Ms. Progebin – The bill goes to the home owner only. If they request it can go to the tenant as well. Either one can sign up for the alerts.

Mr. Andrews – suggested discussing the landlord / tenant language. Maybe the township should require that both the landlord and tenant get the alerts.

Mayor Womack asked should resolution 82-2.22 be pulled for further discussion or keep it on the consent agenda.

# Reports from Mayor, Council, Administrator, CFO

Mr. Andrews – Residents have to be involved it's getting really old with How Lane and other areas like Livingston Avenue.
