WHEREAS, the Township of North Brunswick has a need for a professional to provide public relations consulting services for calendar year 2022; and

WHEREAS, services were procured in formal manner in accordance with Local Public Contracts Law <u>N.J.S.A.</u> 40A:11-4.1a et seq., under both a fair and open and competitive process to assure that each person and/or firm is provided an equal opportunity to respond to the RFP; and

WHEREAS, on Wednesday, November 10, 2021, the Purchasing Agent received, and the Municipal Clerk witnessed, the receipt of one proposal in response to PRO22027; and

WHEREAS, the Evaluation Committee, designated to review proposals and make a recommendation, has completed the review process and included herein their Evaluation Report; and

WHEREAS, the Evaluation Committee recommends authorizing a contract with Burton Trent Public Affairs LLC (144-A West State Street Trenton, NJ 08608) and determined them responsive in all respects and qualified for the position; and

WHEREAS, proposals have been reviewed and the response submitted by Burton Trent Public Affairs LLC has been determined to be responsive under the provisions of the Local Public Contracts Law <u>N.J.S.A</u>. 40A:11-1 et seq. and any provisions of the revised statutes of the State of New Jersey; and

WHEREAS, Burton Trent Public Affairs LLC shall be compensated for these services as outlined within their contract for an authorization not-to-exceed \$60,000.00 for calendar year 2022; and

WHEREAS, the Chief Financial Officer has certified that \$10,000.00 is available for this purpose in FY2022 Legal OE budget account 2-01-20-155-000-984, excluding special services which shall be charged to the related accounts as certified by the Chief Financial Officer, for services ending June 30, 2022 and the balance shall be certified upon the appropriation of funds in FY2023.

NOW, THEREFORE, BE IT RESOLVED on this 3rd day of January, 2022, that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to

execute and the Township Clerk to witness an agreement with Burton Trent Public Affairs LLC to provide public relations consulting services for calendar year 2022, with a contract authorization not-to-exceed \$60,000.00, exclusive of special project services.

BE IT FURTHER RESOLVED notice of this action shall be published in the Home News & Tribune within 10 (ten) days after its passage.

EVALUATION REPORT 2022 PUBLIC RELATIONS - REQUEST FOR PROPOSAL DECEMBER 20, 2021

As part of its annual award of professional service agreements in accordance with "Fair and Open" procurement process established in the State of New Jersey pursuant to <u>N.J.S.A.</u> 19:44A-20.1 et seq., North Brunswick Township solicited Requests for Proposals (RFP) for Public Relations Consulting Services for calendar year 2022.

The Township Council authorized the solicitation of proposals for said service. The process under a formal RFP allows for factors other than price to be taken into consideration when awarding a contract. This process also requires that a committee be established to evaluate proposals in accordance with "weighted" criteria established prior to solicitation of proposals.

Pursuant to <u>N.J.A.C</u> 5:34-4.3, the Township established a three (3) person committee comprised of the following individuals:

Michael C. Hritz, Director of Community Development Joseph Battaglia, Chief of Public Safety Cory Harris, Police Captain

Each committee member assessed their own affiliations and financial interest, as well as the affiliations and financial interests of family members, to ensure that there was no conflict with potential vendors. Each member signed a statement attesting to the fact that there was no conflict of interest.

The committee reviewed and discussed the Request for Proposal and alternative evaluation criteria. The committee agreed to the criteria to be evaluated and the numerical weighting to be assigned to each. The established weighting criterion was as follows:

- 1. Understanding and Prior Experience with the township 30 points
- 2. Experience and Qualifications of Individuals 20 points
- 3. Overall company history 30 points
- 4. Agreement to the Pricing Model 20 points

There was one (1) proposal received by the submission deadline:

Burton Trent Public Affairs LLC 144-A West State Street Trenton, NJ 08608

The committee members individually reviewed the proposals.

Burton Trent Public Affairs LLC is seeking its third contract with the township and has been responsive and performed admirably over the past two years. The firm newly scored a total of 285 points.

Accordingly, the committee recommends the award of contract to Burton Trent Public Affairs LLC.
