

**A RESOLUTION OF THE TOWNSHIP COUNCIL OF NORTH BRUNSWICK  
AUTHORIZING PROFESSIONAL SERVICE AGREEMENTS WITH  
ARCARI AND IOVINO ARCHITECTS, LLC AND  
USA ARCHITECTS, PLANNERS AND INTERIOR DESIGNERS LTD.  
TO PROVIDE ARCHITECTURAL SERVICES**

**WHEREAS**, the Department of Public Works is responsible for providing maintenance and upgrades to municipal buildings; and

**WHEREAS**, it has been determined there is a need to solicit proposals for Architectural Services for potential general and specialized projects; and

**WHEREAS**, municipal structures within the scope of this contract include the following: parks facilities, the Senior Center, the Municipal Complex, the Public Library, and Public Works facilities; and

**WHEREAS**, on September 27, 2021, the Township Council approved Resolution 278-9.21, authorizing the solicitation of Requests for Proposals (RFP) for said professional services; and

**WHEREAS**, services were procured in formal manner in accordance with Local Public Contracts Law N.J.S.A. 40A:11-4.1a et seq., under both a fair and open and competitive process to assure that each person and/or firm is provided an equal opportunity to respond to the RFP; and

**WHEREAS**, on Wednesday, November 10, 2021, the Purchasing Agent received, and the Municipal Clerk witnessed, the receipt of three proposals in response to PRO22017; and

**WHEREAS**, the Evaluation Committee, designated to review proposals and make a recommendation, has completed the review process and included herein their Evaluation Report; and

**WHEREAS**, the Evaluation Committee recommends authorizing contracts with the following two firms: Arcari and Iovino, P.C. (1 Katherine Street, Little Ferry, New Jersey 07643) and USA Architects, Planners and Interior Designers, Ltd. (20 N Doughty Avenue Somerville, NJ 08876) to provide Architectural Services for calendar year 2022; and

**WHEREAS**, proposals have been reviewed and the response submitted by Arcari and Iovino, P.C. and USA Architects, Planners and Interior Designers Ltd. have been determined to be responsive under the provisions of the Local Public Contracts Law N.J.S.A. 40A:11-1 et seq. and any provisions of the revised statutes of the State of New Jersey; and

**WHEREAS**, it is in the best interest of the Township of North Brunswick to enter into agreements with Arcari and Iovino, P.C. and USA Architects, Planners and Interior Designers Ltd. to provide Architectural Services for calendar year 2022; and

**WHEREAS**, Arcari and Iovino, P.C., shall be compensated for these services as outlined within the rate schedule within the contract, with an authorization not-to-exceed \$10,000.00 for general matters, exclusive of special projects; and

**WHEREAS**, the Chief Financial Officer has certified that \$5,000.00 is available for general matters in account 2-01-26-310-000-200 for services ending June 30, 2022 and the balance of authorized funds shall be certified upon the appropriation of funds in FY2023.

**WHEREAS**, USA Architects, Planners and Interior Designers Ltd., shall be compensated for these services as outlined within the rate schedule within the contract, with an authorization not-to-exceed \$10,000.00 for general matters, exclusive of special projects; and

**WHEREAS**, the Chief Financial Officer has certified that \$5,000.00 is available for general matters in account 2-01-26-310-000-200 for services ending June 30, 2022 and the balance of authorized funds shall be certified upon the appropriation of funds in FY2023.

**NOW, THEREFORE, BE IT RESOLVED** on this 3<sup>rd</sup> day of January, 2022, that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness agreements with Arcari and Iovino, P.C. and USA Architects, Planners and Interior Designers Ltd. to provide Architectural Services, to provide Architectural Services for calendar year 2021 in accordance with RFP PRO22017.

**BE IT FURTHER RESOLVED** notice of this action shall be published in the Home News & Tribune as required by law within 10 (ten) days after its passage.

EVALUATION REPORT  
MUNICIPAL ARCHITECT  
REQUEST FOR PROPOSAL PRO22017  
DECEMBER 28, 2021

The Township of North Brunswick seeks a qualified firm to serve as municipal architect for the municipality in 2022. Three (3) proposals were received, all demonstrating general experience and meeting the fundamental qualifications of the services required. A three person committee evaluated the proposals comprised of the following individuals:

Andrei Alexeev Zoning Officer

Michael Hritz, Director of Community Development

Eric Chaszar, Director of Public Works

In addition to the committee reviewing proposals, Legal Counsel was engaged to reviewed proposals submitted for legal compliance.

Each committee member assessed their own affiliations and financial interest, as well as the affiliations and financial interests of family members, to ensure that there was no conflict of interest with vendors in the field. Each member signed a statement attesting to the fact that there was no conflict of interest.

The committee agreed to the criteria to be evaluated and the numerical weighting to be assigned to each. The established weighting criterion was as follows:

- Understanding of Service- 0-30 points
- Prior Experience of Individual/ Team Identified- 0-20 points
- Overall Company History w/similar services- 0-30 points
- Agreement to pricing model- 0-20points

On September 27, 2021, the Township Council passed resolution 278-9.21 authorizing the solicitation of proposals for said service. The following Two (3) proposals were received by the submission deadline of November 10, 2021:

The committee members all individually reviewed each proposal and filled out Committee Evaluation Forms, assigning numerical scores for each firm.

Arcari & Iovino Architects received the highest points overall at 270. USA Architects scored a 265 and there were no exceptions noted on either proposal. Arcari and Iovino Architects and USA Architects are both engaged in projects for the Township. It was noted that both companies have expertise in their fields.

As a result of the evaluation on December 28, 2021, the committee recommends that Arcari & Iovino Architects and USA Architects be awarded the 2022 contact based upon overall scoring on the criteria established and review of the proposal.
