

**A RESOLUTION OF THE TOWNSHIP COUNCIL OF NORTH BRUNSWICK  
CONFIRMING THE APPOINTMENT OF CHRISTINE HEITMANN AS MUNICIPAL  
COURT JUDGE FOR THE TOWNSHIP OF NORTH BRUNSWICK**

**WHEREAS**, in 2008 Judge Christine Heitmann was first appointed to serve as a Municipal Court Judge for the Municipal Court of the Township of North Brunswick (pursuant to resolution 346-11.08); and

**WHEREAS**, in 2011 Judge Christine Heitmann was reappointed to serve as a Municipal Court Judge for the Municipal Court of the Township of North Brunswick, beginning May 21, 2011 and ending May 20, 2014 (pursuant to Resolution 221-8.11); and

**WHEREAS**, in 2014 Judge Christine Heitmann was reappointed to serve as a Municipal Court Judge for the Municipal Court of the Township of North Brunswick, beginning May 21, 2014 and ending May 20, 2017 (pursuant to Resolution 149-5.14); and

**WHEREAS**, in 2017 Judge Christine Heitmann was reappointed to serve as a Municipal Court Judge for the Municipal Court of the Township of North Brunswick, beginning May 21, 2017 and ending May 20, 2020 (pursuant to Resolution 164-6.17); and

**WHEREAS**, Judge Heitmann has served with professionalism and distinction during her term and Mayor Womack wishes to nominate her for reappointment as Municipal Court Judge for another three-year term, retroactive effective May 21, 2020 and ending May 20, 2023; and

**WHEREAS**, the Township Council wishes to consent to the reappointment of Christine Heitmann as a Municipal Court Judge for the Municipal Court of the Township of North Brunswick.

**NOW, THEREFORE, BE IT RESOLVED** on this 10<sup>th</sup> day of January 2022, pursuant to N.J.S.A.2B:12-4, the Township Council of the Township of North Brunswick, County of Middlesex, and State of New Jersey, confirms the Mayor’s appointment of Christine Heitmann to serve as Municipal Court Judge, with a retroactive effective date of May 21, 2020; and

**BE IT FURTHER RESOLVED** Township Council hereby gives its advice and consent to such appointment for another term of three (3) years ending on May 20, 2023 or until such time as a successor is appointed and qualified.
