WHEREAS, the Township of North Brunswick has a need to acquire Water and Wastewater Consulting Services for calendar year 2022; and

WHEREAS, on September 27, 2021, the Township Council approved Resolution 278-9.21, authorizing the solicitation of Requests for Proposals (RFP) for said professional services; and

WHEREAS, services were procured in formal manner in accordance with Local Public Contracts Law <u>N.J.S.A.</u> 40A:11-4.1a et seq., under both a fair and open and competitive process to assure that each person and/or firm is provided an equal opportunity to respond to the RFP; and

WHEREAS, on Wednesday, November 10, 2021, the Purchasing Agent received, and the Municipal Clerk witnessed, the receipt of two proposals in response to PRO22014; and

WHEREAS, the Evaluation Committee, designated to review proposals and make a recommendation, has completed the review process and included herein their Evaluation Report; and

WHEREAS the Evaluation Committee recommends authorizing a contract with CME Associates (3141 Bordentown Avenue Parlin, NJ 08859) to provide Water and Wastewater Consulting Services; and

WHEREAS, proposals have been reviewed and the response submitted by CME Associates has been determined to be responsive under the provisions of the Local Public Contracts Law <u>N.J.S.A</u>. 40A:11-1 et seq. and any provisions of the revised statutes of the State of New Jersey; and

WHEREAS, it is in the best interest of the Township of North Brunswick to enter into an agreement with CME Associates to provide Water and Wastewater Consulting Services for calendar year 2022; and

WHEREAS, compensation for these services shall be billed at an hourly rate of \$165.00 for partners and associates, a blended hourly rate of \$75.00 for clerks and paralegals, travel, and reimbursable expenses as described within the contract for a total authorization not-to-exceed \$60,000.00 for calendar year 2022; and

WHEREAS, the Chief Financial Officer has certified that \$20,000.00 is available for this purpose in the Water Utility account 2-05-55-502-000-200 and \$20,000.00 is available for this purpose in the Wastewater Utility account 2-07-55-502-000-200 for services ending June 30, 2022 and the balance of funds shall be certified upon the appropriation of funds in FY2023.

NOW, THEREFORE, BE IT RESOLVED on this 3rd day of January, 2022, that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an agreement with CME Associates to provide Water and Wastewater Consulting Services, with an authorization not-to-exceed \$60,000.00 for calendar year 2022, in accordance with RFP PRO22014.

BE IT FURTHER RESOLVED notice of this action shall be published in the Home News & Tribune as required by law within 10 (ten) days after its passage.

EVALUATION REPORT WATER/WASTEWATER CONSULTING SERVICES REQUEST FOR PROPOSAL PRO22014 DECEMBER 26, 2022

The Township of North Brunswick seeks a qualified vendor to provide water/wastewater consulting services for the municipality in 2022. Two (2) proposals were received, all demonstrating general experience and meeting the fundamental qualifications of the services required. A three-person committee evaluated the proposals comprised of the following individuals:

Steven Bloyed, Superintendent of Sewer Salvatore Georgianna Supervisor Sewer Division Eric Chaszar, Director of Public Works

In addition to the committee reviewing proposals, Legal Counsel was engaged to reviewed proposals submitted for legal compliance.

Each committee member assessed their own affiliations and financial interest, as well as the affiliations and financial interests of family members, to ensure that there was no conflict of interest with vendors in the field. Each member signed a statement attesting to the fact that there was no conflict of interest.

The committee reviewed the Request for Proposal and alternative evaluation criteria. The committee agreed to the criteria to be evaluated and the numerical weighting to be assigned to each. The established weighting criterion was as follows:

- 1. Respondent's understanding and prior experience with Township -30 points
- 2. Experience and Qualifications of Individuals or Team 20 points
- 3. Respondents overall company history and Experience 30 points
- 4. Pricing Model 20 points

On September 27, 2021, the Township Council passed resolution #278-9.21 authorizing the solicitation of proposals for said service. Two (2) proposals were received by the submission deadline of November 13, 2020

In review the criteria for understanding and experience with North Brunswick, CME Associates demonstrated a good understanding of the services requested and rated the highest overall with a score of 270 points. T&M Associates ranked second with 263 points overall.

As a result of its evaluation on December 26, 2021, the committee recommended that CME Associates be awarded the contract based upon overall scoring on the criteria established and review of the proposal.
