

A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK CONFIRMING THE APPLICATION AND AUTHORIZING THE ACCEPTANCE OF FUNDS UNDER THE NEW JERSEY DEPARTMENT OF COMMUNITY AFFAIRS GRANT PROGRAM TOWARDS THE HERMANN ROAD PAVILION PROJECT

WHEREAS, in 2020 North Brunswick Police Chief Joe Battaglia began working with Mayor Womack, Board of Education Superintendent Jane Ciarrocca and local PBA/SOA on an initiative to offer police programs that brings at-risk youth and local police together to address the challenges that today's youth face; and

WHEREAS, these programs will provide guidance and mentorship during the years when our community's at-risk youth are most vulnerable; and

WHEREAS, the mission is to save a young life when the child might otherwise take a negative path that could include school drop-out, violence and addiction; and

WHEREAS, to construct a pavilion along Hermann Road in-between the Township Police station and Linwood School to accommodate outdoor youth programming, including a re-launch of the Junior Police Academy and engaging sessions that teach skills necessary to resolve daily conflicts; and

WHEREAS, in May of 2022, Assemblyman Danielsen's office received a request from the Township for financial assistance in funding this project through the Grant Program under the New Jersey Department of Community Affairs; and

WHEREAS, Assemblyman Danielsen's office has provided notification that the Township will receive \$500,000 towards the Hermann Road Pavilion Project, located Hermann Road.

NOW, THEREFORE, BE IT RESOLVED, the Township Council of the Township of North Brunswick does hereby confirm the application and authorize the acceptance of funding under the New Jersey Department of Community Affairs in the amount of \$500,000 to assist in the construction costs towards the Hermann Road Pavilion Project.
