

**A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK  
AUTHORIZING THE ADVERTISEMENT  
FOR THE RECEIPT OF BIDS  
FOR THE 2022 ROAD IMPROVEMENT PROGRAM**

**WHEREAS**, the Department of Community Development is responsible for construction and improvements of various municipal streets, roads and curbing; and

**WHEREAS**, municipal officials for the Department, previously engaged municipal engineering firm CME Associates to provide design through bid phase services relating to the 2022 Road Improvements Program; and

**WHEREAS**, road segments include:

1. Antonio Drive (entire length)
2. Hartland Commons (Hadleigh Lane to Aaron Road)
3. Hickory Lane (entire length)
4. Hidden Lake Drive (Nathan Drive to Rt. 27)
5. La Rose Avenue (Iris Street to Rt. 27)
6. Princess Drive / Regal Court (Cozzens Lane to brook)
7. Riverbend Drive (entire length) (Delete Item 2)
8. Todd Circle (entire length) (Delete Item 1)
9. How Lane (sanitary sewer improvements between the pumping station and the storage facility)

**WHEREAS**, with design through bid phase services complete, the Director hereby recommends that the Township solicit proposals for this project, known as the 2022 Road Improvement Program; and

**WHEREAS**, the goods and services requested is anticipated to exceed the current bid threshold, and is therefore required to be bid under a formal competitive bid process pursuant to Local Public Contract Law N.J.S.A. 40A:11-3 et seq.
