

**A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK
AUTHORIZING AN AWARD OF CONTRACT TO
GARDEN STATE HIGHWAY PRODUCTS INC.
UNDER THE DEPARTMENT OF PUBLIC SAFETY
FOR THE PURCHASE OF ONE TRAFFIC MESSAGE BOARD**

WHEREAS, portable traffic message boards offer safe and simple control for short-term and long-term applications and can be used in a number of scenarios; and

WHEREAS, under the Department of Public Safety, there is a need to purchase a new traffic message board used to alert public of traffic patterns, road closures, events, etc.; and

WHEREAS, it is hereby the Chief's recommendation to the Mayor and Council to solicit proposals for the purchase of (1) traffic message board; and

WHEREAS, on August 1, 2022, the Township Council approved Resolution #226-8.22 which acknowledged the solicitation of quotations for the purchase of one (1) traffic message board; and

WHEREAS, two (2) quotes were received on October 13, 2022; and

WHEREAS, the quote submitted by Garden State Highway Products, Inc. (301 Riverside Drive Millville, NJ 08332) in the amount of \$20,143.42 for purchase of one (1) traffic message board was determined to be the most responsive and responsible respondent; and

NOW THEREFORE, BE IT RESOLVED, that the formal quote submitted by Garden State Highway Products, Inc. is hereby accepted.

BE IT FURTHER RESOLVED, on this 24th day of October 2022, that the Township Council of the Township of North Brunswick does hereby acknowledge and authorize the execution of contract PRO22044, awarded to Garden State Highway Products, Inc. for the purchase of one (1) traffic message board in the amount of 20,143.42.
