A RESOLUTION OF THE TOWNSHIP COUNCIL OF NORTH BRUNSWICK AUTHORIZING A CHANGE IN SCOPE TO

THE PROFESSIONAL SERVICE AGREEMENT WITH CME ASSOCIATES APPOINTED AS THE 2022 TOWNSHIP CONSULTING ENGINEERING FIRM FOR PROFESSIONAL SERVICES ASSOCIATED WITH THE OLD GEORGES ROAD WATER MAIN REHABILITATION PROJECT

WHEREAS, in January of 2022, pursuant to Resolution 8-1.22, CME Associates, of 3141 Bordentown Avenue, Parlin, NJ 08959, was authorized to provide engineering consulting services for calendar year 2022, as awarded under a fair and open contract process, pursuant to the provisions of N.J.S.A. 19:44A-20.1 et seq.; and

WHEREAS, CME Associates current agreement includes the following:

- → General engineering services in an amount not-to-exceed \$100,000.00,
- Professional services associated with Pulda Farm Walking Trail Project-Phase 2 in the amount of \$34,791.00,
- Professional services associated with Pulda Farm Walking Trail Project-Phase 3 in the amount of \$24,735.00,
- Professional services associated with the North Brunswick Community Park Trail Improvements Project in the amount of \$27,754.00 and
- Professional services associated with the Construction Phase for the 2022 Road Program, with an amount not-to-exceed \$362,000.00, for a revised contract amount of \$549,280.00.

WHEREAS, the Township is the owner of the Water Treatment Plant and Distribution System which includes water lines that conveys "potable" water to its customers; and

WHEREAS, rehabilitation is needed for a section of an existing 12" cast iron water main that runs under Old Georges Road off Route 130; and



WHEREAS, as part of the NJ I-Bank application, the costs for the construction administration phase of the project must be authorized prior to the solicitation for bids, and therefore CME Associates has been requested to provide a proposal for services associated with the construction phase for the Old Georges Road Rehabilitation Project; and

WHEREAS, compensation for requested services associated with the Old Georges Road Rehabilitation Project shall be based upon the July 29, 2022 proposal submitted by CME Associates, to be paid upon submission of monthly invoices, with an amount not-to-exceed \$, and a revised contract authorization amount of \$669,027.00.
