

**A RESOLUTION AUTHORIZING THE AWARD OF CONTRACT BID22007
TO SHORE TOP CONSTRUCTION CORP.
FOR THE IMPROVEMENTS OF TENNIS COURTS**

WHEREAS, Hermann Park and Brunswick Knolls Park both include tennis courts that are in need of improvements; and

WHEREAS, it is the Director's recommendation to the Governing Body to receive bids for the Tennis Courts Improvements at the Brunswick Knolls Park and Hermann Park; and

WHEREAS, this project will be funded through Parks Improvements Capital; and

WHEREAS, on May 16, 2022 the Township Council approved Resolution #154-5.22 authorizing advertisement for receipt of bids for Tennis Courts Improvements, BID22007; and

WHEREAS, Nellie Sowell, witnessed the receipt of two (2) bids on May 25, 2022; and

WHEREAS, the bid submitted by Shore Top Construction Corp. (23 Yellowbrook Road Freehold, NJ 07728) in the amount of \$70,000.00, for the tennis courts at Hermann Park and in the amount of \$105,000.00 for the tennis courts at Brunswick Knolls, for a total of \$175,000.00 was determined to be the lowest responsible and responsive bidder; and

WHEREAS, Township Attorney Ronald Gordon has reviewed the bid submitted by Shore Top Construction Corp. and determined them responsive under the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey; and

NOW THEREFORE, BE IT RESOLVED, that the bid submitted by Shore Top Construction Corp. is hereby accepted.

BE IT FURTHER RESOLVED, on this 31st day of May 2022, that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute, and the Township Clerk to witness, an agreement with Shore Top Construction Corp. for the Tennis Courts Improvements at Hermann Park and Brunswick Knolls Park, in the amount \$175,000.00.
