

**A RESOLUTION AUTHORIZING THE AWARD OF CONTRACT BID22005  
TO INTERSTATE WASTE SERVICES OF NEW JERSEY  
DBA CENTRAL JERSEY WASTE AND RECYCLING  
UNDER THE DEPARTMENT OF PUBLIC WORKS FOR  
REFUSE COLLECTION SERVICES**

**WHEREAS**, the Department of Public Works Sanitation Division is responsible for providing for refuse and recycling collection services to residential homes, apartment and condominium associations, as well as various properties that include North Brunswick Board of Education facilities, nonprofit organizations and houses of worship; and

**WHEREAS**, currently the Township contracts out with Central Jersey Waste and Recycling, Inc. (432 Stokes Avenue, Ewing, NJ 08638) to provide *refuse and recycling* collection services to apartment associations; and

**WHEREAS**, the Township provides in-house *refuse* collection for Condominium Associations, as well as various properties that include North Brunswick Board of Education facilities, nonprofit organizations and houses of worship; and contracts out *recycling* collection with Middlesex County Improvement Authority under a Shared Services Agreement at these locations; and

**WHEREAS**, the current agreement with Central Jersey Waste and Recycling, Inc. to provide *refuse and recycling* collection services to Apartment Associations ends August 30, 2022 and;

**WHEREAS**, on April 11, 2022 Township Council approved Resolution #128-4.22 authorizing the advertisement for the receipt of bids for refuse and recycling collection services; and

**WHEREAS**, on July 14, 2022 the Clerk witnessed the receipt of (1) one bid submitted by Interstate Waste Services of New Jersey dba Central Jersey Waste and Recycling (432 Stokes Avenue Ewing, NJ 08638) in the amount of \$3,226,903.68 for refuse and \$1,656,927.36 for recycling, totaling \$4,883,831.04 for five years; and

**WHEREAS**, Ron Gordon, appointed Municipal Legal Counsel, has reviewed the bid submitted and determined the bid submitted by Interstate Waste Services of New Jersey dba Central Jersey Waste and Recycling to be responsive under the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey; and

**WHEREAS**, within the bid specifications, the Township reserved the right to award the contract based on refuse ONLY, or recycling ONLY or for both refuse and recycling; and

**WHEREAS**, Director of Public Works Eric Chaszar has also reviewed the bid and recommends approval of the base bid submitted by Interstate Waste Services of New Jersey dba Central Jersey Waste and Recycling with a “not-to-exceed” amount of \$3,226,903.68 for *refuse ONLY* collection services to Apartment Associations based on estimated quantities provided within the bid document and a five-year term beginning September 1, 2022 and ending August 30, 2027; and

**WHEREAS**, the Director has reviewed the Bid Options with the Mayor and Administrator and concludes it is most advantageous to continue providing services in-house at this time, but recommends reserving the Options as priced in the bid, shall it be determined in the best interest to authorize under the contract; and

**WHEREAS**, the recycling collection for Apartment Associations will be amended and included with Middlesex County Improvement Authority under a current Shared Services Agreement; and

**WHEREAS**, the Chief Financial Officer certifies that funds have been made available within the FY2023 Sanitation OE budget and the balance shall be certified upon the appropriation of funds in future budgets.

**NOW THEREFORE, BE IT RESOLVED**, that the bid submitted by Interstate Waste Services of New Jersey dba Central Jersey Waste and Recycling is hereby accepted.

**BE IT FURTHER RESOLVED**, on this 1st of August 2022 that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an agreement with Interstate Waste Services of New Jersey dba Central Jersey Waste and Recycling to provide *refuse ONLY* collection services to Apartment Associations, reserving the Options priced as bid, pursuant to contract BID22005, in an amount not-to-exceed \$3,226,903.68, with a five-year term (September 1, 2022 – August 30, 2027).
