

**A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK  
AUTHORIZING CHANGE ORDER NO. 1 WITH  
SHORE TOP CONSTRUCTION CORP.  
UNDER CONTRACT BID22007  
FOR THE IMPROVEMENTS OF TENNIS COURTS**

**WHEREAS**, Hermann Park and Brunswick Knolls Park both include tennis courts that are in need of improvements; and

**WHEREAS**, it is the Director's recommendation to the Governing Body to receive bids for the Tennis Courts Improvements at the Brunswick Knolls Park and Hermann Park; and

**WHEREAS**, on May 31, 2022 the Township Council approved Resolution #173-5.22 authorizing contract BID2007 with Shore Top Construction Corp. in the amount of \$175,000.00 for Tennis Courts Improvements; and

**WHEREAS**, due to unforeseen grading issue with the courts at Brunswick Knolls Park, there is significant repair that needs to be done; and

**WHEREAS**, Shore Top Construction Corp. has submitted a proposal in the amount of \$26,800.00 (Change Order No. 1); and

**WHEREAS**, Eric Chaszar, the Director of Public Works, along with the Parks Division have reviewed the scope of work recommended and determined it necessary to include the repair of the grading under the courts at Brunswick Knoll park under contract BID22007 and hereby recommend approval of Change Order No. 1.

**NOW THEREFORE, BE IT RESOLVED**, that the Township Council of the Township of North Brunswick does hereby authorize the Mayor or Business Administrator to execute Change Order No. 1 with Shore Top Construction Corp. under Contract BID22007 for Tennis Court Improvements, with an increase in the contract amount by \$26,800.00 for Brunswick Knolls court grading repair work, for a revised contract amount of \$201,800.00.
