AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 334 VEHICLES AND TRAFFIC OF THE CODE OF THE TOWNSHIP OF NORTH BRUNSWICK TO AMEND TRAFFIC CONTROLS ON BLACKHORSE LANE

WHEREAS, N.J.S.A. 39:4-197 <u>et seq</u>., permits a municipality to enact an ordinance regulating the parking of vehicles on streets and portions thereof and establish certain traffic controls without NJDOT review or involvement; and

WHEREAS, the Director of Community Development has determined, in conjunction with the Traffic Safety Bureau, that parking conditions on Blackhorse Lane should be amended to promote pedestrian and traffic;

NOW, THEREFORE, BE IT ORDAINED, by the Township Council of the Township of North Brunswick, that Chapter 334-30, <u>Vehicles and Traffic</u>, Article XIII, Schedule I: No Parking, be and is hereby amended and supplemented to include no parking as follows:

Name of Street	Side	Location
Blackhorse Lane	Both	From Route 130 to terminus

BE IT FURTHER ORDAINED, if any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section paragraph, subsection, clause or provision so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective.

BE IT FURTHER ORDAINED, any ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict.

BE IT FURTHER ORDAINED, this Ordinance shall take effect upon passage and publication in accordance with applicable law.

TITLE

This Ordinance shall be known and may be cited as the Ordinance Authorizing Traffic Controls on Blackhorse Lane
