# A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK CONFIRMING AN EMERGENCY AND THE PURCHASE OF DECALS FOR THE REPLACEMENT VEHICLES UNDER THE DEPARTMENT OF PUBLIC SAFETY

WHEREAS, Tropical Storm Ida impacted New Jersey on Wednesday, September 1, 2021, bringing severe weather conditions including strong winds, reports of tornadoes, and heavy and sustained rainfall which was forecasted to reach up to ten (10) inches in some areas; and

WHEREAS, the tropical storm caused severe damage to North Brunswick's municipal facilities, infrastructure and equipment which could endanger the community's health, safety, and welfare if not responded to in an immediate manner; and

**WHEREAS**, on Thursday, September 2, 2021, the Mayor for the Township declared a State of Emergency for the Township; and

WHEREAS, under the Department of Public Safety, several vehicles have been affected by the flooding at the Municipal Complex parking lot during Tropical Storm; and

**WHEREAS,** on Thursday, September 2, 2021 the Police Chief provided necessary information to open a loss claim with the Garden State Joint Insurance Fund; and

**WHEREAS**, in September of 2021, pursuant to Resolutions #276-9.21, #283-9.21, #284-9.21, #285-9.21 and #286-9.21 the Township authorized contracts with several vendors for the emergency supply and delivery of replacement public safety vehicles; and

WHEREAS, the replacement vehicles need the proper decals installed that was also included on the vehicle loss claim with the Garden State Joint Insurance Fund; and

**WHEREAS**, Grafix Solutions, Inc. (201 Hartle Street Suite C Sayreville, NJ 08872) is the current vendor that installs/repairs decals on all our public safety vehicles; and

WHEREAS, pursuant to N.J.S.A. 40A:11-6 et seq. under the Local Public Contract Law, any contract may be negotiated or awarded for a contracting unit without public advertising for bids and bidding therefor, notwithstanding that the contract price will exceed the bid threshold, when an emergency affecting the public health, safety or welfare requires the immediate delivery of goods or the performance of services; and

WHEREAS, prior to entering onto a contract with the Township, Grafix Solutions, Inc. has completed and submitted a Business Entity Disclosure Certification, attached hereto, which certifies that they have not made any reportable contributions to a political or candidate committee in the Township of North Brunswick in the previous one year, and that the contract will prohibit Grafix Solutions, Inc. from making any reportable contributions through the term of the contract; and
