A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK  
APPROVING A LARGE EVENT APPLICATION FOR THE  
2<sup>nd</sup> DANIEL ANDERL LOVE IS LIGHT 5K WALK/RUN EVENT

**WHEREAS**, in July of 2020, Daniel Anderl son of North Brunswick residents U.S. District Court Judge Esther Salas and defense attorney Mark Anderl had his life ended when a gunman, posing as a delivery person, opened fire in the door of their home; and

**WHEREAS**, soon thereafter, a volunteer Planning Committee formed with a mission to honor Daniel Anderl, who sacrificed his life to protect his family, to raise funds for academic scholarships and to bring awareness of the Daniel Anderl Judicial Security and Privacy Act of 2020"; and

**WHEREAS**, pursuant to Ordinance 19-09 which amended North Brunswick Municipal Code 166-1 et seq., "Public Entertainment", any event not hosted by the municipality that anticipates a large gathering shall require approval in advance by the governing body including: a circus, carnival, fair, festival/celebration, concert, exhibition, car show, parade/procession, expo, fundraiser, scholar event competition, multi-team organized sporting event, run/walk/bike/triathlon, or hobby; and

**WHEREAS**, the Planning Committee has made application to the Municipal Clerk to hold a large event on July 16, 2022 know as the "2<sup>nd</sup> Daniel Anderl Love is Light 5k Walk/Run" that requires the use of municipal services; and

**WHEREAS**, pursuant to Municipal Code 166-1 et seq., the applicant shall be responsible to pay for the cost of all municipal services, including, but not limited to, Public Works, Parks, Office of Emergency Management, and extra-duty for Police force services.

**NOW THEREFORE, BE IT RESOLVED**, on this 27<sup>th</sup> day of June 2022, the Township Council of the Township of North Brunswick does hereby approve the Large Event Application for "2<sup>nd</sup> Daniel Anderl Love is Light 5k Walk/Run".
