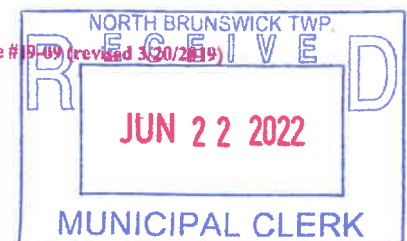

Narrative:

The 2nd/Last Daniel Anderl Love is Light 5K is an event planned for Saturday, July 16, 2022 with no rain date. The event is planned to be held in the North Brunswick Community Park, North Brunswick Township, New Jersey. The event times to include set up and clean up are estimated to be 6:00 AM to 3:00 PM.

The purpose of this event is for scholarship fundraising in honor of Daniel Anderl, member of the Saint Augustine of Canterbury School, Class of 2014. The sponsor of the event is Saint Augustine of Canterbury School, 45 Henderson Rd., Kendall Park, NJ 08824 (known as "the sponsor" going forward in this document).

CHECKLIST

Police:

The North Brunswick Police Department has been in contact with the United States Marshals regularly to assess the needs and proper staffing for event management.

Public Works:

Event Volunteers will assist Public Works staff with emptying trash bags and assisting where needed. Public Works staff will be needed for this event; any cost or fees associated with this staff should be directed to Lou Ann Benson along with any necessary paperwork/contract needed for signature by the sponsor.

Bathrooms are requested; based on the status of Covid protocol, public bathrooms or Port-O-Johns are required.

Set up of tables, chairs, and tents (if needed), will require the assistance of both the event volunteers and the Public Works staff. The same will follow for clean up and breakdown of the event.

Medical:

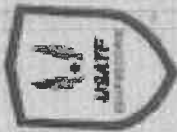

Start: On park road 8 feet east of the fire hydrant on the north side of the road that is between the Dog Park parking lot and the bridge.

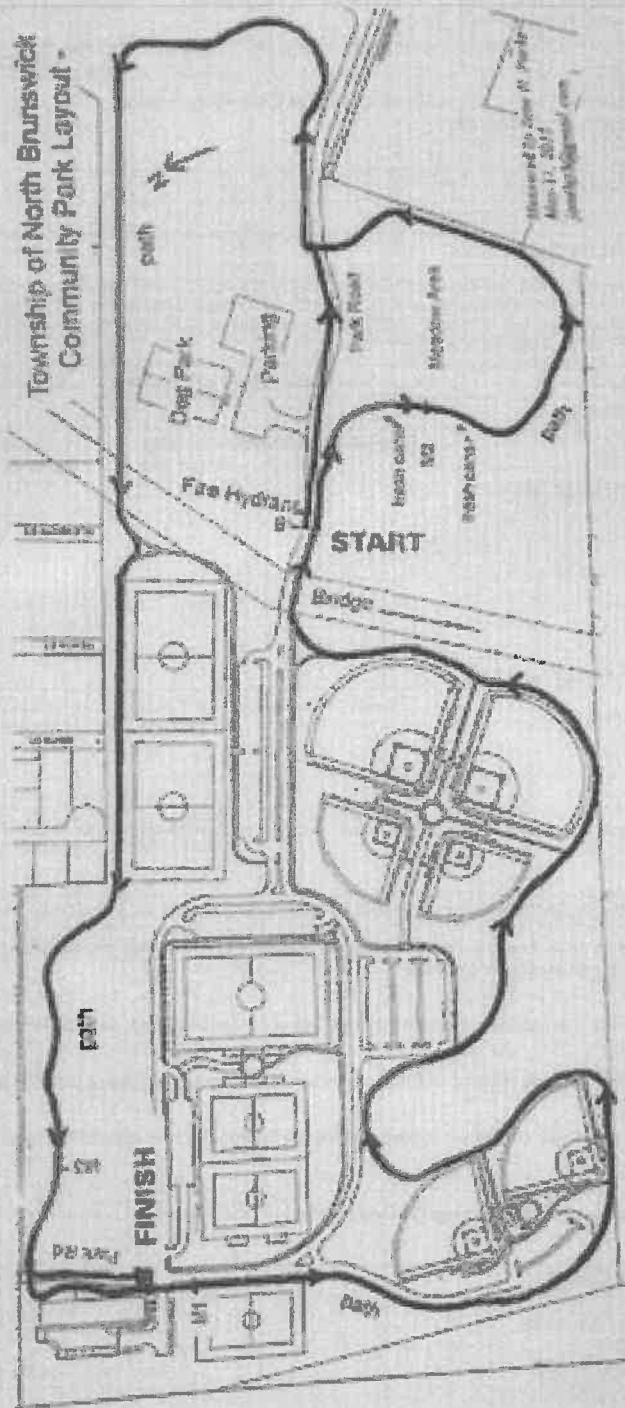

Mile 2: On park path, 67 feet after the first set of trash cans on the right and 56 feet before the second set of trash cans on the right running south around the tennis courts.

Mile 3: On park path 14 feet before the Mile 2 sign on the left for the path loop distance.

Finish: On park road by the maintenance area at the southern edge of the stop sign line in the road.

Course Notes: The course is a loop and a half on the outmost path around the park. The course starts and finishes on the park road.

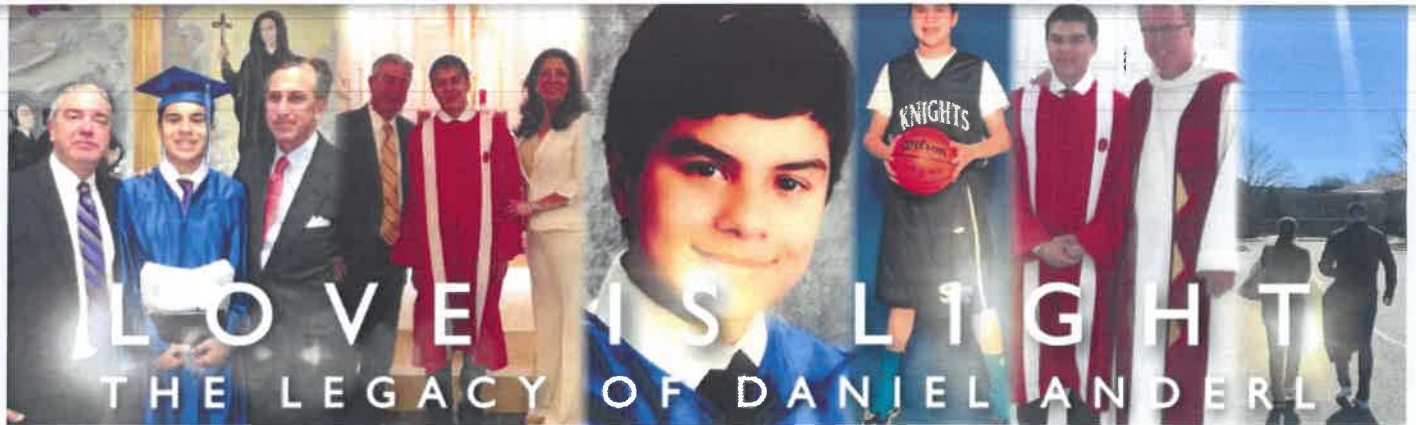

On Saturday, July 16th, **The 2nd/Last Daniel Anderl "Love is Light" 5K**, will be held at the **North Brunswick Community Park**, commemorating the second anniversary of Daniel's death. The many friends of Danny Anderl from the Saint Augustine's School and North Brunswick communities, organized this event to continue the memory of this incredible young man.

The purpose of the **"Love is Light"** 5K Run/Walk is three-fold, it is intended to:

- *Honor Daniel's legacy, who selflessly sacrificed his own life to protect his mother and father*
- *Advocate to create national legislation that protects members of the judiciary, as evidenced by the signing of New Jersey Bill A1649, the Daniel Anderl Judicial Security and Privacy Act of 2020 ("Daniel's Law") that protects the privacy and security of members of the judiciary*
- *Raise funds for academic student scholarships.*

All net proceeds from this event will fund the creation of an endowed academic scholarship in Daniel's memory at his grammar school alma mater Saint Augustine of Canterbury School in Kendall Park, N.J. **The Daniel Anderl Class of 2014 Scholarship Fund** has a goal of **\$100,000** which will provide for an annual academic award in Danny's name in perpetuity.

Danny was a smart, funny, compassionate, competitive, caring and loyal person. He was a popular student-athlete at Saint A's and graduated in 2014 with honors.

**AGREEMENT
BY AND BETWEEN:**

THE TOWNSHIP OF NORTH BRUNSWICK
(hereinafter referred to as the "Municipality")

AND

ST. AUGUSTINE OF CANTERBURY SCHOOL
(hereinafter referred to as "Employer")

WHEREAS, the Employer herein named desires to hire and retain police officers during their off duty hours, which officers are regularly employed by the Municipality; and

WHEREAS, the Municipality agrees to permit the utilization of these police officers during their off duty hours.

NOW THEREFORE, both parties mutually agree:

1. The Employer shall pay to the Municipality the sum of **\$66.90** per hour, per officer, for police officers assigned to the Employer by the Municipality for services, such as security, crowd control, traffic control, or other related duties, approved by the Municipality's Chief of Police.
2. The Employer shall hold the Municipality harmless from any and all claims that may arise as the result of activities or actions of the police officer hired by the Employer.
3. The Employer shall provide the Municipality, prior to the hiring of the Municipality's police officer(s), with a Certificate of Insurance from an Insurance Company acceptable to the Municipality evidencing and disclosing not less than \$1,000,000.00 in General Liability, as well as a properly executed copy of this Agreement insuring to the benefit of the Municipality and shall maintain said coverage at all times that a police officer of the Municipality is employed by the Employer.
4. A minimum of 4 Hours is required for any scheduled job.

5. Payment is required the day of the detail in the form of a check made out to: The Township of North Brunswick. Any subsequent jobs will be invoiced after the job is completed.

6. Job cancellations must be made two (2) hours prior to the scheduled start of the detail. Failure to make timely notification will be billed a minimum of four (4) hours per officer. Notification is to be made through the North Brunswick Police Dispatch at (732) 545-3200, opt #1.

7. Signed and sealed this 24 day of June by the corporate officers of the Municipality and the Employer.
