A RESOLUTION AUTHORIZING THE ADVERTISEMENT FOR RECEIPT OF BIDS FOR THE

MUNICIPAL COMPLEX ROOF AND GUTTER REPLACEMENT PROJECT UNDER THE DEPARTMENT OF PUBLIC WORKS

WHEREAS, in September of 2021, a significant amount of water penetrated the Municipal Complex from Hurricane Ida, causing major damage to the structure, including sections of the roof and gutter system; and

WHEREAS, without addressing the disaster-related damage to the exterior roof and gutter system breached during Hurricane Ida, the building will experience leaks and moisture intrusion, causing future damage to the interior of the building; and

WHEREAS, in November of 2021, the Director of Public Works met Peter Campisano with USA Architects to walk the site and survey the condition of the building; and

WHEREAS, in January of 2022, Peter Campisano with USA Architects met with elected and municipal officials to report on the preliminary findings and discuss repairs necessary to restore the exterior, inclusive of bringing the building to current construction code standards, which will provide future resiliency against weather related events; and

WHEREAS, in the beginning of February 2022, Peter Campisano with USA Architects met with municipal officials and representatives from Federal Emergency Management Agency ("FEMA") to review options for making application under FEMA programs for project assistance; and

WHEREAS, on February 22, 2022 Peter Campisano with USA Architects was engaged to provide services associated with the next phase in remediation and restoration efforts at the Municipal Complex, including the Municipal Complex Roof and Gutter Replacement Project (excluded Courtroom flat roof section); and

WHEREAS, the Director of Public Works and Business Administrator have reviewed the plans and specifications and hereby make a recommendation to the Governing Body to advertise for the receipt of bids for the Municipal Complex Roof and Gutter Replacement Project.

NOW, THEREFORE, BE IT RESOLVED, on this 27th day of June 2022, that the Township Council of the Township of North Brunswick does hereby authorize advertisement for the receipt of bids for the following specification:
