Reports from Mayor, Council, Administrator, CFO

Council President Davis announced that Saturday September 17th was Military Appreciation Day!

Councilman Mehta the seniors had a Bocce Ball game with the Police Dept. and thanked everyone for participating.

Director of Recreations Lou Ann Benson, just a reminder that the 40th Annual Heritage Day will be on Saturday, October 1 from 3 p.m. to 10 p.m. at Community Park. There will be fireworks after the evening band performance. Rain date is Sunday, October 2nd.

Mayor Womack opened the Public Hearing.

Resident Sioban Gibbons spoke on opposing resolution for the gas power plant in Woodbridge.

Mayor Womack explained that the Township is waiting for the Environmental Commission Report.

Resident Anthony "Tony" Nastus wanted to know the status of certain properties which he had discussed with the Mayor in a meeting a few weeks ago. Mr. Nastus provided addresses that he would like addressed 678 Hermann Road, 5 Edgewood Place, 420 Georges Road, Thalia Street, Riverton and Remsen, Newton Street and Ridgewood. Mayor Womack told Mr. Nastus that he has already had answers on these properties. Mr. Hritz told Mr. Nastus that the Township is working on it and that his department is aware of the issues. Mr. Nastus also, asked about school buses being parked at certain homes, Mr. Nastus was told that the ordinance states that 1 bus can be parked in the driveway at a residence. Mr. Nastus wanted to know about OPRA request's and how they are answered the Mayor and Township Attorney Ron Gordon explained that OPRA request must be specific and they are for documents. Mr. Nastus wanted to know about site Triangles and who he should contact he was told to contact the Police

Department Public Safety. Mr. Nastus requested to know the square footage of Hookah lounge Mr. Hritz will provide him with the information.

Charlie Kratavil stated that he was here to support Ms. Gibbons on opposing the gas plant.

Mr. Andrews asked what the alternatives where? And the purpose for the gas plants. The Advocacy needs to be the Solar & Wind now. This is a nationwide thing.

Mayor Womack called for a motion to close Public Hearing, so moved by Council President Davis second by Mr. Mehta.
