

**RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK
AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION TO THE
UNITED STATES OFFICE OF JUVENILE JUSTICE AND DELINQUENCY
PREVENTION UNDER THE O-OJJDP_2022, APPLICATION ID A-456524, ENHANCING
SCHOOL CAPACITY TO ADDRESS YOUTH VIOLENCE GRANT PROGRAM**

WHEREAS, the Township of North Brunswick desires to apply for grant funding in the amount of \$371,000.00 under the United States Office of Juvenile Justice and Delinquency Prevention under the O-OJJDP_2022, Application ID A-456524, Enhancing School Capacity to Address Youth Violence Grant Program; and

WHEREAS, this application is a collaboration between the North Brunswick Township Police Department and the North Brunswick Township School District for the purpose described in the application (ID A-456524).

NOW THEREFORE, BE IT RESOLVED that the Council of the Township of North Brunswick, formally approves the grant application for the above federal grant initiative, with no matching funds required; and

BE IT FURTHER RESOLVED that the Township of North Brunswick is hereby authorized to submit an electronic grant application identified as O-OJJDP_2022, application ID A-456524, to the United States Office of Juvenile Justice and Delinquency Prevention; and

BE IT FURTHER RESOLVED that the Chief of Police is hereby authorized to sign the grant application on behalf of North Brunswick Township and that his signature constitutes acceptance of the terms and conditions of all grant guidelines for submission; and

NOW THEREFORE, BE IT RESOLVED, on this 27th day of June, 2022, the Township Council of the Township of North Brunswick, County of Middlesex, State of New Jersey, authorizes the grant application submission for the amount of \$371,000 to the United States Office of Juvenile Justice and Delinquency Prevention, O-OJJDP_2022, Application ID A-456524.
