

**A RESOLUTION AUTHORIZING THE REJECTION AND READVERTISEMENT
FOR THE RECEIPT OF PROPOSALS
FOR A CONCESSION AGREEMENT
UNDER THE DEPARTMENT PARKS, RECREATION & COMMUNITY SERVICES FOR
SENIOR TRANSPORTATION SERVICES**

WHEREAS, The Township of North Brunswick under the Department of Parks, Recreation and Community Services offers discounted transportation services to registered senior citizens of 62 years of age or over and handicapped residents, known as The Senior Transportation Program; and

WHEREAS, with the current agreement expiring in August 2022 and with the increase in registered participants utilizing the transportation services offered under the program, it has been deemed necessary to solicit proposals to continue to have a dedicated provider servicing The Senior Transportation Program; and

WHEREAS, pursuant to N.J.S.A. 40A:11-4.1(j) et seq. and N.J.A.C. 5:34-9.4 et seq. concession agreements are permitted as the granting of a license or right to act for or on behalf of the contracting unit; and

WHEREAS, the basis of award of the concession will be determined by the most advantageous price and other factors; and

WHEREAS, on June 27, 2022 the Township Council of the Township of North Brunswick approved Resolution #191-6.22 authorizing advertisement for the receipt of proposals for senior transportation services; and

WHEREAS, on July 19, 2022, the Municipal Clerk, witnessed the receipt of one (1) proposal submitted by Ride Roundtrip, Inc. (with offices at 441 N. 5th Street, Suite 201 Philadelphia, PA 19123); and

WHEREAS, in their proposal submission, Ride Roundtrip, Inc. failed to submit a properly executed Non-Collusion Affidavit; and

WHEREAS, Township Attorney Ronald Gordon has reviewed the proposal submitted by Ride Roundtrip, Inc. and deemed it to be unresponsive under the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and any provisions of the revised statutes of the State of New Jersey;

NOW THEREFORE, BE IT RESOLVED, on this 1st day of August 2022, that the Township Council of the Township of North Brunswick does hereby reject all proposals received for Contract BID22009.

BE IT FURTHER RESOLVED, that the Township Council of the Township of North Brunswick hereby authorizes the re-advertisement and re-bidding of BID22009 for the receipt of proposals for the following:
