

**A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK
AUTHORIZING A CHANGE ORDER
FOR THE EMERGENCY REPAIR OF A JET VAC TRUCK
UNDER THE DEPARTMENT OF PUBLIC WORKS**

WHEREAS, the Stormwater Management Division is responsible for maintaining the entire Township stormwater infrastructure in accordance with New Jersey Department of Environmental Protection Stormwater Best Management Practices; and

WHEREAS, jet-vac trucks are the ideal way to maintain healthy stormwater systems to effectively clean catch basins, removing grit, leaves and other debris through vacuum and high-pressure water; and

WHEREAS, there was a need to repair vehicle #863 (2006 Sterling LT7500) within the Stormwater Division that currently needs a replacement debris tank; and

WHEREAS, in December of 2021, pursuant to Resolution #331-12.21, the Township authorized an agreement with FS Solutions for the emergency repair of a jet-vac truck as a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.5 in the amount of \$39,428.40; and

WHEREAS, due to the unpredictability of the vehicle needing several attachments that required additional welding, fitting and increased labor costs to produce a safe product, the total amount exceeded the proposal by \$17,296.96, a revised total amount of \$56,725.36; and

WHEREAS, a recommendation is hereby made that the Council authorize amending the agreement with FS Solutions increasing the contract by \$17,296.96 for a revised contract amount of \$56,725.36.

BE IT FURTHER RESOLVED, on this 11th day of April 2022, that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute, and the Township Clerk to witness, an amendment to the agreement with FS Solutions increasing the contract by \$17,296.96 for a revised contract amount of \$56,725.36 for the repair of the debris tank on Vehicle #863.
