We hereby submit our proposal to furnish labor; materials and equipment necessary to provide the following work as per the information that you provided **and** as noted and described herein:

#### SCOPE OF WORK & PRICING

This proposal includes and is limited to removal and replacement of the dog park fence. The six-foot-high fence will consist of a heavier gauge wire, which would require heavier frame work for fence. New fence will be constructed with 3" OD terminal and gate posts, 2.5" OD line posts, 1 5/8" top rail, bottom tension wire, with braces at all terminal and gate posts, and 2" x 6 Ga aluminized wire. All posts and rails to be wt 40 weight, galvanized. All posts to be set in concrete footings. Disposal of existing fence material to be by others:

- 1) Approximately 950 LF of fence
- 2) Two (2), 10 FT Opening Double Swing Gates
- 3) Four (4), 4 FT Opening Single Swing Gates with self closing hinges and latches
- 4) Existing layout to be used with the gate closed off between the big and small dog park.

#### Guardian Fence Co. Inc. will complete this work for the sum of \$51,980.00

#### Break Down

Labor - 1 Foreman @ 64.00 Hr. for 90 Hrs. = \$5,760.00 Labor - 3 Installers @ 68.00 Hr. for 90 Hrs. = \$18,360.00 Materials + 5% Mark-up = \$27,860.00

  - d) Local permits, licenses or fees, traffic control, offsite disposal of excavated materials
  - e) Grounding of fence, asphalt, concrete or landscape restoration, dewatering of holes.
  - Padlocks, all gates will be equipped with only provisions for padlocks f)
