

**A RESOLUTION AUTHORIZING AN AGREEMENT
WITH GUARDIAN FENCE COMPANY, INC.
UNDER THE DEPARTMENT OF PUBLIC WORKS
TO REPLACE THE FENCE IN COMMUNITY PARK**

WHEREAS, the Parks Division under the Department of Public Works, provides for maintenance and improvements of Parks and various Township property; and

WHEREAS, at Community Park, residents and visitors enjoy walking/biking paths, playgrounds, soccer and baseball fields, etc.; and

WHEREAS, the fences located at Community Park need replacement; and

WHEREAS, Guardian Fence Company, Inc. is an approved vendor under the current Cooperative Pricing Agreement with the Hunterdon County Bid #HCESC-Cat/Ser-19-16 for Fencing Repair & Replacement, and;

WHEREAS, Guardian Fence Company, Inc., with offices located at 180 Wright Street Newark, NJ 07114, has submitted a proposal in the amount of \$76,776.77 to replace the fence at Community Park; and

NOW THEREFORE BE IT RESOLVED, that the Township Council of the Township of North Brunswick does hereby authorize an award of contract to Guardian Fence Company, Inc. in the amount of 76,776.77 to replace the fence at Community Park; and

BE IT FURTHER RESOLVED, that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an agreement with Guardian Fence Company in accordance with the previously approved Hunterdon County Cooperative Pricing Agreement Bid #HCESC-Cat/Ser-19-16.

We hereby submit our proposal to furnish labor; materials and equipment necessary to provide the following work as per the information that you provided **and** as noted and described herein:

SCOPE OF WORK & PRICING

This proposal includes and is limited to:

- 1) Remove and Replace approximately 2500 LF of Round Cedar Split Rail Fence with 3 rails. All rails to be paddled ends. All posts to be augured, backfilled and tamped.
- 2) Furnish and install approximately 140 LF of four-foot-high black chain link fence system. The fence will consist of 2.5" OD terminal posts, 2" Line posts, 1 5/8" OD to run along top and bottom of fence line, and 2" x 6 ga black wire. All pipe to be WT 40 weight poly coated black. All posts to be dug and set in concrete footings.

Guardian Fence Co. Inc. will complete this work for the sum of \$76,776.77

Break Down

Labor - 1 Foreman @ 64.00 Hr. for 140 Hrs. = \$8,960.00

Labor - 3 Installers @ 68.00 Hr. for 140 Hrs. = \$28,560.00

Materials @ 39,256.77

TERMS, CONDITIONS & EXCEPTIONS

This proposal is a conditional offer and is subject to the following as stated or as checked:

- 1) This proposal is valid for 15 days.
- 2) Regarding New Jersey/New York Sales and Use Tax: Sales tax must be added to all prices if and as applicable.
- 3) You will accept our standard insurance coverage's and limits. Please contact the undersigned for a sample Certificate of Insurance. Bonds of any kind including performance and payment will be made available at additional cost.
- 4) The following items of work **are not included** in our proposal:
 - a) Layout, locating of property lines, fence lines, grades, and related work.
 - b) Engineering and "as built" drawings. Any and all PE services are excluded from this proposal.
 - c) Locating and mark-out of all underground utilities, vaults, sprinkler systems etc. not covered by NJ one call. This includes any test pits that may be required.
 - d) Local permits, licenses or fees, traffic control, offsite disposal of excavated materials
 - e) Grounding of fence, asphalt, concrete or landscape restoration, dewatering of holes.
 - f) Padlocks, all gates will be equipped with only provisions for padlocks
