WHEREAS, the North Brunswick Volunteer Fire and Rescue Company #3 has requested from the Township an operational vehicle for fire company use; and

WHEREAS, the Township has a 2003 Ford F-350 Utility vehicle (VIN# 1FDWF37F33EA67327), that is no longer needed for municipal purposes and is currently scheduled to be auctioned; and

WHEREAS, pursuant to New Jersey Local Public Contact Law, N.J.S.A. 40A: 11-36(2), a municipality is permitted to convey property no longer needed for public use to other political entities without public sale; and

WHEREAS, the Mayor and Council have determined that it is in the best interest of the Township to convey the title to the 2003 Ford F-350 Utility vehicle (VIN# 1FDWF37F33EA67327) to the North Brunswick Volunteer Fire and Rescue Company #3.
