

**A RESOLUTION APPROVING AND PROVIDING NOTICE ON THE PUBLIC
HEARING FOR THE FISCAL YEAR 2023 BUDGET**

WHEREAS, the Municipal Budget of the Township of North Brunswick, County of Middlesex for the Fiscal Year 2023 requires Council approval prior to August 10, 2022; and

WHEREAS, the Mayor presented the Council the Fiscal Year 2023 Budget for review and consideration prior to July 30, 2022; and

WHEREAS, the Township Council has had the opportunity to review the Fiscal Year 2023 Budget.
