

**RESOLUTION APPROVING BUDGET AMENDMENT

Dear Mayor Womack III:

I am pleased to inform you that North Brunswick has been awarded \$73,761.00 through the New Jersey Department of Transportation's (NJDOT) Highway Safety Fund grant program for 2022. Under the Safe Corridors Act, the Highway Safety Fund is generated by fines and penalties imposed and collected in designated stretches of state highways known as Safe Corridors. Highway Safety Fund grants, intended to promote public safety, are distributed to the municipalities that are responsible for law enforcement within the Safe Corridors. Eligible uses for grants include procurement of enforcement equipment such as police vehicles, radar, communication and surveillance equipment, crash data hardware and software systems and salaries.

The Highway Safety Program, administered by the NJDOT, utilizes a performance-based formula to determine grants for individual municipalities. This data-driven method assesses several metrics, including crash rates and crash severity, and directs more resources to those areas within Safe Corridors exhibiting the greatest need for continued enhanced enforcement measures.

Applications for the 2022 Highway Safety Program must be completed and submitted by **June 9, 2022** on-line through SAGE at <https://njsage.intelligrants.com/Login2.aspx?APPTHEME=NJSAGE>
