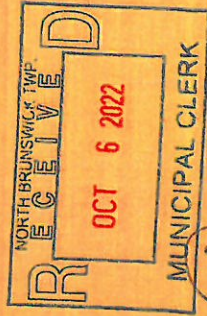

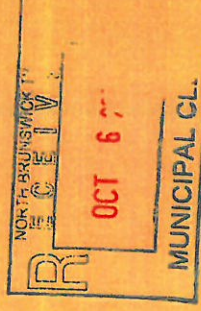

A. BASE BID

and Addenda thereto as furnished by USA Architects, P.A., for the total sum of:

One Million Seven Hundred Forty-Nine Thousand
Five Hundred Dollars (\$1,749,500.00).

B. ALLOWANCES – See Section 01 21 00

The undersigned bidder hereby affirms that the specified allowances, as described and required in
Specification Section 01 21 00 – Allowances are included in this bid proposal.

Allowance No. 01: (General Allowance) \$25,000.00 (TWENTY-FIVE THOUSAND DOLLARS). Contractor to
include a general repair allowance to address any unforeseen project conditions. All un-used allowances
shall be fully credited back to the Owner up to 100% of the allowance. Allowance work shall be approved
by written authorization prior to any work being performed.

C. UNIT PRICE SCHEDULE – See Section 01 22 00

The undersigned agrees that the following shall constitute the Unit Prices, to be applicable to additions to
or deductions from the quantities contemplated by the contract documents by reason of changes or
omissions in or to the contract documents in the course of performance of the contemplated work.

Prices shall include all materials, labor, transportation, tools, equipment, services and installations
necessary to complete the work described. Overhead, insurance and profit shall also be included.
