

**A RESOLUTION AUTHORIZING RECLASIFICATION OF
COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDS FOR
PROGRAM YEAR 2021**

WHEREAS, the Township Council of the Township of North Brunswick received notice, from the office of Middlesex County Housing and Community Development, of a Community Development Block Grant (CDBG) for program year 2021 in the amount of \$118,714.00; and

WHEREAS, program funding of \$118,714.00 was previously approved to be utilized for the Individual Housing Rehabilitation Program, Code Enforcement Property Maintenance Program, Senior Citizen Center ADA Building Improvements, and a Public Library Book Drop Project for the fiscal year July 1, 2020 – June 30, 2021; and

WHEREAS, the Director of Community Development and the CDBG Grant Coordinator have determined that funding for these purposes should be reclassified from the Individual Housing Rehabilitation Program to the Community Park ADA Trail Improvement Project; and

WHEREAS, the reclassification of these funds has been reviewed by the Middlesex County Housing and Community Development office and they support the proposed use of funds;

NOW THEREFORE BE IT RESOLVED, on the 17th day of January, 2023, by the Township Council of the Township of North Brunswick, that the use of CDBG funds are hereby reclassified in accordance with the recommendation of Director of Community Development and the CDBG Grant Coordinator, and supported by the office of Middlesex County Housing and Community Development, as follows:

Community Park ADA Trail Improvements:	\$ 50,000.00
Code Enforcement Salary Reimbursement:	\$ 40,000.00
Senior Citizen Center ADA Building Improvements	\$ 16,714.00
Public Library Book Drop Project	\$12,000.00
TOTAL	\$118,714.00

BE IT FURTHER RESOLVED, that the Mayor and Township Clerk are hereby authorized to execute all documents and agreements necessary in support of this grant funding.
