A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK AUTHORIZING AN AMENDMENT TO CONTRACT BID19002 WITH C3 TECHNOLOGIES, LLC

FOR REPORTING, CONSULTING, MAINTENANCE AND REPAIR OF MUNICIPAL UNDERGROUND STORAGE TANKS

WHEREAS, the Department of Public Works Building Maintenance Division is responsible for providing the maintenance and repairs of municipal facilities; and

WHEREAS, the Township has five Underground Storage Tank (UST) locations (782 Canal Road, 200 Edlys Lane, 851 Oliver Avenue, 36 Princess Drive and 45 Quarry Lane); and

WHEREAS, as of October 31, 2018 licensed operators are required by State and Federal Laws in New Jersey for the operation of regulated Underground Storage Tanks to ensure that owners and operators of USTs properly operate and maintain UST systems; and

WHEREAS, under the New Jersey and Federal EPA guidelines, each UST system or group of UST systems, must have a Class A, Class B and Class C Operator designated pertaining to operating and maintaining the UST system(s); and

WHEREAS, in addition to reporting and maintenance services, during a preliminary review of the municipal Underground Storage Tanks, it was determined that repairs are needed at some of the locations; and

WHEREAS, in February of 2019, pursuant to Resolution 78-2.19, the Township authorized a contract with C3 Technologies, LLC (with offices at 501 Adams Lane, Suite 1, North Brunswick, New Jersey 08902) to provide UST reporting, consulting, maintenance and repair services, on an as-needed basis, for a total contract authorization of \$300,000.00, with a three-year term beginning February 1, 2019 and ending December 31, 2021, and included the option for two additional one-year extensions; and

WHEREAS, in February of 2022, pursuant to Resolution #78-2.22, the Township authorized an amendment to the contract with C3 Technologies, LLC to provide UST reporting, consulting, maintenance and repair services, on an as-needed basis, with a one-year extension beginning January 1, 2022 and ending December 31, 2022 and a not-to-exceed amount of 300,000.00; and

WHEREAS, Steven Bloyed, Acting Director of the Department of Public Works, determined there is a continued need to have a third-party company available to provide UST reporting, consulting, maintenance and repair services and recommends authorizing a one-year extension with no increase in the current authorization amount of \$300,000.00; and

WHEREAS, the Chief Financial Officer has certified that \$5,000.00 is available for this purpose in FY2023 Buildings and Grounds Operating – Equipment Repair Account 3-01-26-310-000-151 for services ending June 30, 2023 and the balance shall be certified upon the appropriation of funding in future fiscal years; and

WHEREAS, the Chief Financial Officer has certified that \$5,000.00 is available for this purpose in FY2023 Sewer Operating – Maintenance and Repair Account 3-07-55-502-000-183 for services ending June 30, 2022 and the balance shall be certified upon the appropriation of funding in future fiscal years.

NOW, THEREFORE, BE IT RESOLVED, on this 6th day of February 2023 that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an amendment to the agreement C3 Technologies, LLC extending the contract term by one year, from January 1, 2023 – December 31, 2023, for UST reporting, consulting, maintenance and repair services, with no increase in the current authorization amount of \$300,000.00, pursuant to contract BID19002.
