

RESOLUTION TO ACCEPT A DONATION OF FIVE THOUSAND DOLLARS (\$5,000.00) FROM USPL NUTRITIONALS LLC

WHEREAS, N.J.S.A. 40-A:5-29 permits municipalities to accept bequests, legacies and gifts made to it and is empowered to utilize such bequests, legacies and gifts in the manner set forth in the condition of the bequest, legacy or gift, provided, however, that such bequests, legacy or gift shall not be put in to any use which is inconsistent with the laws of this State and of the United States; and

NOW THEREFORE, BE IT RESOLVED on this 17th Day of January, 2023, by the Township Council of North Brunswick Township, Middlesex County, State of New Jersey, that the Mayor or his designee are hereby authorized to execute and sign any and all documents in order to effectuate the receipt of said monies between North Brunswick Township and USPL Nutritionals LLC in the amount of \$5,000.00.
