

**AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 334-3.3  
VEHICLES AND TRAFFIC  
OF THE CODE OF THE TOWNSHIP OF NORTH BRUNSWICK**

**WHEREAS**, the Director of Community Development, in conjunction with the Chief of Police and the Traffic Safety Bureau, has determined that regulations for parking within the public right-of-way require amendment; and

**NOW, THEREFORE, BE IT ORDAINED**, by the Township Council of the Township of North Brunswick, that Chapter 334, Vehicles and Traffic, “Article II Parking; Stopping or Standing; Time Limit Parking,” is hereby supplemented with a new section 334-3.3 as follows:

**§ 334-3.3      Parking Obstructions and Encumbrances in Streets.**

No person shall obstruct or encumber any street, road, highway, public lane, alley, or parking space within the public right-of-way by placing thereon any object such as garbage cans, furniture, boxes, lumber, traffic cones, or any other item whatsoever, in an effort to obstruct or encumber passage, or block parking spaces or areas from being available for public use where parking is otherwise legally permitted.

**BE IT FURTHER ORDAINED**, if any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section paragraph, subsection, clause or provision so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective.

**BE IT FURTHER ORDAINED**, any ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict.

**BE IT FURTHER ORDAINED**, this Ordinance shall take effect upon passage and publication in accordance with applicable law.

**TITLE**

This Ordinance shall be known as may be cited as the Ordinance Amending and Supplementing Chapter 334-3.3 Vehicles and Traffic of the Code of the Township of North Brunswick
