A RESOLUTION OF CONCURRENCE BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF NORTH BRUNSWICK FOR THE NEW JERSEY DEPARTMENT OF TRANSPORTATION DESIGNATING BUS STOPS ON ROUTE 171-GEORGES ROAD

WHEREAS, the New Jersey Department of Transportation (NJDOT) has requested a resolution of support from the municipal governing body in order to promulgate a Traffic Regulation Order (TRO) for Route 171-Georges Road; and

WHEREAS, New Jersey Transit has proposed two (2) bus stops located on Route 171-Georges Road; and,

WHEREAS, the New Jersey Department of Transportation (NJDOT) and the Bureau of Traffic Engineering (BTE) share the township's concern for motorist and pedestrian safety and, based upon a field investigation, support the designation of these bus stop locations; and

WHEREAS, both the Department of Community Development and the Traffic Safety Bureau endorse the designation of two (2) bus stops.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of North Brunswick, Middlesex County, State of New Jersey, that in accordance with N.J.S.A. Title 39:4-8c, the Commissioner of Transportation be requested to adopt a regulation to affect the following bus stop locations on Route 171-Georges Road and permission is hereby granted to erect appropriate signs at the following Bus Stops:

Bus Stops:

Along Route NJ 171, northbound, on the easterly side thereof at:

A. Pardun Road (far side) (NJ Transit ID# 33198)
 Beginning at the northerly curb line of Pardun Road and extending 100-feet northerly therefrom.

Along Route NJ 171, southbound, on the westerly side thereof at:

B. Cranbury Cross Road (near side) (NJ Transit ID# 33199)
Beginning at the northerly curb line of Cranbury Cross Road and extending 105-feet northerly therefrom

BE IT FURTHER RESOLVED, that the Township of North Brunswick concurs to a Repealer Clause that any approved bus stop locations or traffic regulations in conflict with or inconsistent with the provisions of this resolution be rescinded upon approval of the Traffic Regulation Order.

BE IT FURTHER RESOLVED that this resolution shall take effect upon approval of the Commissioner of Transportation as provided by law.

BE IT FURTHER RESOLVED that the Township Council of North Brunswick will enforce the Traffic Regulation Order governing the aforementioned bus stop locations and parking restrictions and provide the necessary police security to ensure the safety of the traveling public.
